Proposed Regularisation of 'Columbarium' Uses (for Columbarium Niches Sold before 30.6.2017 only) at Part of G/F to 6/F of an Existing Building, known as The Emperor Hall, in "Government, Institution or Community" Zone, No. 18 Sha Tau Kok Road, On Lok Tsuen, Lung Yeuk Tau, Fanling, New Territories (Planning Application No.: A/FSS/275)

On 29.4.2020, the Private Columbarium Affairs Office ("PCAO") of the Food and Environmental Hygiene Department conducted a site inspection to verify the number of existing columbarium niches under application (i.e. solely for those sold before 30.6.2017) in the application premises; on 15.6.2020, PCAO then issued a letter to the Applicant to request for provision of further information to clarify its observations and concerns with respect to its Application for Temporary Suspension of Liability and Licence; and on 29.6.2020, the Applicant submitted to PCAO a set of information required by its office (Annex A). In order to allow sufficient time for PCAO to verify the submitted information and is hoping that its office can confirm the number of existing columbarium niches under application thereafter, the Applicant would now like to request a deferment of the Rural and New Town Planning Committee Meeting that will consider the captioned application for a period of two months.
