Relevant Interim Criteria for Consideration of Application for New Territories Exempted House (NTEH)/Small House in New Territories (promulgated on 7.9.2007)

- (a) sympathetic consideration may be given if not less than 50% of the proposed NTEH/Small House footprint falls within the village 'environs' ('VE') of a recognized village and there is a general shortage of land in meeting the demand for Small House development in the "Village Type Development" ("V") zone of the village;
- (b) if more than 50% of the proposed NTEH/Small House footprint is located outside the 'VE', favourable consideration could be given if not less than 50% of the proposed NTEH/Small House footprint falls within the "V" zone, provided that there is a general shortage of land in meeting the demand for Small House development in the "V" zone and the other criteria can be satisfied;
- (c) development of NTEH/Small House with more than 50% of the footprint outside both the 'VE' and the "V" zone would normally not be approved unless under very exceptional circumstances (e.g. the application site has a building status under the lease, or approving the application could help achieve certain planning objectives such as phasing out of obnoxious but legal existing uses);
- (d) application for NTEH/Small House with previous planning permission lapsed will be considered on its own merits. In general, proposed development which is not in line with the criteria would normally not be allowed. However, sympathetic consideration may be given if there are specific circumstances to justify the cases, such as the site is an infill site among existing NTEHs/Small Houses, the processing of the Small House grant is already at an advance stage;
- (e) if an application site involves more than one NTEH/Small House, application of the above criteria would be on individual NTEH/Small House basis;
- (f) the proposed development should not frustrate the planning intention of the particular zone in which the application site is located;
- (g) the proposed development should be compatible in terms of land use, scale, design and layout, with the surrounding area/development;
- (h) the proposed development should not encroach onto the planned road network and should not cause adverse traffic, environmental, landscape, drainage, sewerage and geotechnical impacts on the surrounding areas. Any such potential impacts should be mitigated to the satisfaction of relevant Government departments;
- (i) the proposed development, if located within water gathering grounds, should be able to be connected to existing or planned sewerage system in the area except under very

special circumstances (e.g. the application site has a building status under the lease or the applicant can demonstrate that the water quality within water gathering grounds will not be affected by the proposed development*);

- (j) the provision of fire service installations and emergency vehicular access, if required, should be appropriate with the scale of the development and in compliance with relevant standards; and
- (k) all other statutory or non-statutory requirements of relevant Government departments must be met. Depending on the specific land use zoning of the application site, other Town Planning Board guidelines should be observed, as appropriate.
- *i.e. The applicant can demonstrate that effluent discharge from the proposed development will be in compliance with the effluent standards as stipulated in the Water Pollution Control Ordinance Technical Memorandum.

Reasons for Rejection

- R1 The proposed development is not in line with the planning intention of the "Agriculture" zone in the Tsui Keng area.
- R2 Land is still available within the "V" zone of Chan Uk Po. It is considered more appropriate to concentrate the proposed Small House development close to the existing village cluster for more orderly development pattern, efficient use of land and provision of infrastructures and services.
- R3 The application does not comply with the Interim Criteria for Consideration of Application for NTEH/Small House in New Territories in that more than 50% of the footprints of the proposed Small House falls outside both the village 'environs' and "V" zone of Chan Uk Po of Tsiu Keng Village.

Detailed Comments from Relevant Government Departments

1. Land Administration

Comments of the District * ands Officer/North, Lands Department (DLO/N, LandsD):

- (a) the Sites fall entirely within the Village 'Environ' ('VE') of Tsiu Keng Village;
- (b) the applicants claimed themselves as indigenous villagers of Sheung Shui Village. Their eligibility for Small House concessionary grants has yet to be ascertained;
- (c) the Sites are not covered by any Modification of Tenancy / Building Licence;
- (d) the Sites are Old Schedule agricultural lots;
- (e) the number of outstanding Small House applications in Tsiu Keng Village is 39. As provided by the Indigenous Inhabitant Representative of Tsiu Keng on 1.8.2017, the number of 10-year Small House demand for the Tsiu Keng Village is 220; and
- (f) the Small House applications at the Sites were received on 7.11.2013.

2. Drainage

Comments of the Chief Engineer/Mainland North, Drainage Services Department (CE/MN, DSD):

- (a) he has no objection in principle to the applications from public drainage viewpoint; and
- (b) should the applications be approved, approval condition should be included to request the applicants to submit and implement a drainage proposal for the Sites to ensure that it will not cause adverse drainage impact to the adjacent area.

3. Environment

3.1 Comments of the CE/MN, DSD:

the Sites are in an area where no public sewerage connection is available.

- 3.2 Comments of the Director of Environmental Protection (DEP):
 - (a) in view of the small-scale nature of the proposed developments, the applications alone are unlikely to cause major pollution; and

(b) septic tank and soakaway system is an acceptable means for collection, treatment and disposal of the sewage provided that its design and construction follow the requirements of the Practice Note for Professional Person (ProPECC) PN 5/93 "Drainage Plans subject to Comment by the Environmental Protection Department" and are duly certified by an Authorized Person.

4. Agriculture

Comments of the Director of Agriculture, Fisheries and Conservation (DAFC):

- (a) he has no strong view against the applications from agricultural point of view;
- (b) the Sites are currently hard paved and occupied by two temporary structures. Surrounded by domestic and other temporary structures, the Sites possess low potential for agricultural rehabilitation; and
- (c) it is noted that the Sites are near a watercourse, which is at the upstream of Tam Shui Hang. Should the applications be approved, the applicants should be reminded to implement good site practice so as not to pollute the watercourse nearby.

5. Water Supply

Comments of the Chief Engineer/Construction, Water Supplies Department (CE/C, WSD):

- (a) he has no objection to the applications; and
- (b) for provision of water supply to the developments, the applicants may need to extend their inside services to the nearest suitable Government water mains for connection. The applicants shall resolve any land matter (such as private lots) associated with the provision of water supply and shall be responsible for the construction, operation and maintenance of the inside services within the private lots to his standards.

6. Landscape

Comments of the Chief Town Planner/Urban Design and Landscape, Planning Department (CTP/UD&L, PlanD):

- (a) he has no objection to the application from the landscape planning perspective;
- (b) according to the aerial photo taken in 2017, the surrounding area was comprised of vacant lands, car parks, village houses and scattered tree groups. The proposed use is considered not incompatible with the existing landscape setting in proximity;
- (c) based on his site visit conducted on 24.4.2019, the Sites were hard paved with temporary structures erected. Further significant landscape impact arising from the proposed use is not anticipated; and
- (d) in view that the proposed use is not adjoining any prominent public frontage and would not cause further significant landscape and visual impacts, the landscape

condition is not recommended, should the applications be approved.

7. Fire Safety

Comments of the Director of Fire Services (D of FS):

he has no specific comment on the applications. The applicants are advised to observe 'New Territories Exempted Houses - A Guide to Fire Safety Requirements' published by LandsD. Detailed fire safety requirements will be formulated upon receipt of formal application referred by the LandsD.

8. Traffic

Comments of the Commissioner for Transport (C for T):

- (a) he has reservation on the applications. The Small House developments should be confined within the "Village Type Development" ("V") zone as far as possible. Although additional traffic generated by the proposed developments are not expected to be significant, such type of developments outside the "V" zone, if permitted, will set undesirable precedent cases for similar applications in the future. The resulting cumulative adverse traffic impact could be substantial; and
- (b) notwithstanding the above, the two applications each only involve construction of one Small House. He considers that the applications can be tolerated unless they are rejected on other grounds.

The applicant shall resolve any land matter (such as private lots) associated with the provision of water supply and shall be responsible for the construction, operation and maintenance of the inside services within the private lots to his department's standard;
- (d) to note the comments of the Director of Fire Services to observe 'New Territories Exempted Houses - A Guide to Fire Safety Requirements' published by the Lands Department. Detailed fire safety requirements will be formulated upon receipt of formal application referred by the Lands Department; and
- (e) to note the Comments of the Director of Agriculture, Fisheries and Conservation that the Site is near a watercourse, which is at the upstream of Tam Shui Hang. The applicant should implement good site practice so as not to pollute the watercourse nearby.
