We have received comments from Transport Department (TD) sent to us via DPO/TM&YLW's email dated 10.9.2018 on our Further Information submitted on 31.8.2018. We request that the consideration of the planning application by the Town Planning Board would be deferred for two months so as to allow more time for the consultants to address the following issues:

- to assess the capacity of the temporary lay-by provided at Hing Choi Street;
