## Approval Condition(s)

- (2) The provision of stormwater disposal facilities.
- (3) The permission shall cease to have effect on 1.6.2004 unless prior to the said date wither the development hereby permitted is commenced or the permission is renewed.

#### Advisory Clauses for Application No. A/TM/525

- (a) To note comments of CBS/NTW, BD that:
  - (i) Before any new building works (including erection of containers and connection of drains) are to be carried out on the Site, prior approval and consent of the BD should be obtained, otherwise, they are UBW. An Authorized Person (AP) should be appointed as the co-ordinator for the proposed building works in accordance with the BO.
  - (ii) For UBW erected on leased land, enforcement action may be taken by the BD to effect their removal in accordance with BD's enforcement policy against UBW as and when necessary. The granting of any planning approval should not be construed as an acceptance of any existing building works or UBW on the Site under the BO.
  - (iii) In connection with (i) above, the Site shall be provided with means of obtaining access thereto from a street and emergency vehicular access in accordance with Regulations 5 and 41D of the Building (Planning) Regulations respectively.
  - (iv) If the Site does not abut on a specified street of not less than 4.5m wide, its permitted development intensity shall be determined under Regulation 19(3) of the Building (Planning) regulations at the building plan submission stage.
  - (v) Detailed comments will be made at the building plan submission stage.

- (c) To note comments of FSD that detailed fire safety requirements will be formulated upon receipt of formal submission of general building plans and the arrangement of EVA shall comply with Section 6, Part D of Code of Practice for Fire Safety in Building 2011 which is administered by the Buildings Department.
- (d) To note comments of ArchSD that the use of combustible polyvinyl chloride as the rooftop material should be reviewed and the roof should be designed in accordance with Building (Construction) Regulation 90 and "Code of Practice for Fire Safety in Buildings 2011".
