Application Proposed Columbarium

Background

- On 10.8.2018, the applicant submitted an application seeking planning permission from the Town Planning Board (the Board) for columbarium use at the application site (the Site) (**Plan A-1**). The proposed number of niches would be 3,000.
- On 5.10.2018, the Rural and New Town Planning Committee (the Committee) 1.2 agreed to defer a decision on the application for two months as requested by the applicant, so as to allow sufficient time to consult relevant departments and address departmental comments. The applicant submitted further information (FI) on

7.12.2018. The application is scheduled for consideration by the Committee at this meeting.

2. Request for Deferment

On 14.1.2019, the applicant's representative wrote to the Secretary of the Town Planning Board and requested the Board to defer making a decision on the application for two months in order to address further comments of some departments (**Appendix I**).

3. Planning Department's Views

- 3.1. The application has been deferred once for two months at the request of the applicant to allow sufficient time to consult and address departmental comments received on the application. Since the last deferment, the applicant has submitted FI, including a revised Traffic Impact Assessment and a response to comment table, in response to comments of government departments. The applicant needs more time to prepare FI in response to further comments of government departments.
- 3.2. The Planning Department <u>has no objection</u> to the request for deferment as the justifications for deferment meet the criteria for deferment as set out in the Town Planning Board Guidelines on Deferment of Decision on Representations, Comments, Further Representations and Applications made under the Town Planning Ordinance (TPB PG-No. 33) in that the applicant needs more time to prepare FI in response to departmental comments, the deferment period is not indefinite and the deferment would not affect the interests of other relevant parties.
- 3.3. Should the Committee agree to defer making a decision on the application, the application will be submitted to the Committee for consideration within two months upon receipt of further submission from the applicant. If the FI submitted by the applicant is not substantial and can be processed within a shorter time, the application could be submitted to an earlier meeting for the Committee's consideration. The applicant should be advised that the Committee has allowed two months for preparation of submission of FI. Since it is the second deferment of the application, the applicant should be advised that the Committee has allowed a total of four months for preparation of submission of FI and no further deferment would be granted unless under very special circumstances.

4. Decision Sought

The Committee is invited to consider whether or not to accede to the applicant's request for deferment. If the request is not acceded to, the application will be submitted for the Committee's consideration at the next meeting.
