Approval Condition(s):

- (1) Submission and/or implementation of landscape and/or tree preservation proposals.
- (2) Paving and/or provision of fencing for the site.
- (3) Submission of drainage proposals/Drainage Impact Assessment and flood mitigation measures proposals and/or provision of drainage facilities.
- (4) Submission and/or implementation of water supplies for firefighting/fire service installations/emergency vehicular access proposal(s)/provision of a 9-litre water type/3kg dry powder fire extinguisher.
- (5) Revocation of planning approval for non-compliance with conditions by a specified date/at any time during the approval period.
- (6) Reinstatement of the application site upon expiry of planning permission.
- (7) No night-time operation during specific time limit.
- (8) No repairing/dismantling/breaking/fixing/maintenance/cleansing/paint-spraying/workshop activities are allowed on the site.
- (9) No operation is allowed on Sundays and public holidays.
- (10) Maintenance of (existing) landscape planting and/or drainage facilities on the site.
- (11) No vehicles over 5.5 tonnes/heavy goods vehicles (i.e. over 24 tonnes) are allowed to be used, parked/stored on the site.

The zoning of the site has been amended to "U" vide the publication of OZP No. O/YL-TYST/1-A on 17.12.1999 to partially meet the objections to OZP No. S/YL-TYST/1 and such zoning amendment was reflected on the draft Tong Yan San Tsuen OZP No. S/YL-TYST/4 which was gazetted on 20.4.2000.

Rejection Reason(s):

- (1) Not in line with the planning intention of the "Green Belt" ("GB") zone.
- (2) The development does not comply with the Town Planning Board Guidelines for "Application for Open Storage and Port Back-up Uses" in that it is not compatible with the surrounding residential/rural land uses/there is adverse departmental comment on the application.
- (3) No/insufficient information in the submission to demonstrate that the development would not generate adverse drainage impact.
- (4) The approval of the application would set an undesirable precedent for other similar applications within the "GB" zone. The cumulative effect of approving such applications would result in a general degradation of the environment of the area.

- (1) Submission and/or implementation of (accepted) landscape and/or tree preservation proposals.
- (2) Paving and/or fencing of the application site.
- (3) Submission of (revised) drainage proposals and/or provision/implementation of (accepted) drainage facilities/proposal.
- (4) Submission and/or implementation of (accepted) water supplies for firefighting/fire service installations/emergency vehicular access proposal(s)/provision of a 9-litre water type/3kg dry powder fire extinguisher.

- (5) Revocation of planning approval for non-compliance with conditions by a specified date/at any time during the approval period.
- (6) Reinstatement of the application site upon expiry of planning permission.
- (7) No open storage is allowed on the site.
- (8) No (night-time) operation during specific time limit is allowed on the site.

Rejection Reason(s):

- (1) No/insufficient information in the submission to demonstrate that the development would not generate adverse environmental impact.

- (2) No/insufficient information in the submission to demonstrate that the development would not generate adverse drainage impact.
- (3) No/insufficient information in the submission to demonstrate that the development would not generate fire safety impact.
- (4) The application involves previously revoked planning permissions due to non-compliance with the approval conditions. Approval of the application with repeated non-compliances would set an undesirable precedent for other similar planning permissions for temporary uses, nullifying statutory planning control.

Advisory clauses

- (a) prior planning permission should have been obtained before commencing the applied development on-site;
- (b) to resolve any land issues relating to the development with the concerned owner(s) of the application site (the Site);
- (c) shorter compliance period is imposed in order to monitor the progress of compliance with approval conditions. Should the applicant fail to comply with any of the approval conditions again resulting in the revocation of planning permission, sympathetic consideration may not be given to any further applications;
- (d) the planning permission is given to the development/uses under application. It does not condone any other development/use (i.e. workshop use) which currently exists on the Site but not covered by the application. The applicant shall be requested to take immediate action to discontinue such development/use not covered by the permission;
- (e) the Site should be kept in a clean and tidy condition at all times;
- (f) to note the comments of the District Lands Officer/Yuen Long, Lands Department (DLO/YL, LandsD) that the Site consists of Old Schedule Agricultural Lots held under Block Government Lease which contains the restriction that no structures are allowed to be erected without the prior approval of the Government. Lots No. 749 and 753, 754 and 760B, 758 and 759, 761, and 762 in D.D.117 are covered by Short Term Waivers (STWs) No. 4481, 4482, 4483, 4484, and 4485 respectively to permit structures erected thereon for the purpose of “Temporary Warehouse for Storage of Clothes and Household Products and Logistics Centre”. The Site is accessible to Kung Um Road via GL and private land. Her office does not provide maintenance work for GL involved and does not guarantee any right-of-way. The STW holders will need to apply to her office for modification of the STW if there is any irregularities on the respective STW sites and the lot owner(s) of the lot without STW will need to apply to her office to permit the structures to be erected or regularize any irregularities on site. Such application(s) will be consider by her department acting in the capacity of the landlord or the lessor at its sole discretion and there is no guarantee that such application(s) will be approved. If such application(s) is approved, it will be subject to such terms and conditions, including among others the payment of premium of fee, as may be imposed by her department;
- (g) to note the comments of the Commissioner for Transport that the land status of the access road/path/track leading to the Site from Kung Um Road shall be checked with the lands authority. The management and maintenance responsibilities of the access road/path/track shall be clarified and consulted with the relevant management and maintenance authorities accordingly. The applicant is reminded that sufficient space should be provided within the Site for manoeuvring of vehicles. In addition, no parking, vehicle queuing and reverse movement of vehicles on public road are allowed;
- (h) to note the comments of the Chief Highway Engineer/New Territories West, Highways Department that adequate drainage measures should be provided at the site access to prevent surface water flowing from the Site to nearby public roads/drains. His department shall not be responsible for the maintenance of any access connecting the Site and Kung Um Road;

- (i) to follow the latest “Code of Practice on Handling the Environmental Aspects of Temporary uses and Open Storages Sites” issued by the Environment Protection Department to minimize any potential environmental nuisances;
- (j) to note the comments of the Chief Town Planner/Urban Design and Landscape, Planning Department (PlanD) that for tree planting, a minimum 1.2m soil depth should be reserved and 1m diameter of tree pit should be provided. Fence and/or kerb or bollard should be constructed with a minimum distance of 1 m around the planting areas to guard against damage to the trees and shrubs. The applicant is reminded to follow the ‘Technical Note on the Submission and Implementation of Landscape Proposals for Compliance with Conditions for Approved Applications for Open Storage and Port Back-up Uses under Section 16 of the Town Planning Ordinance’, and also guidelines promulgated by Development Bureau on tree care and maintenance: (http://www.greening.gov.hk/en/tree_care/tree_maintenance.html);
- (k) to note the comments of the Director of Fire Services that the applicant is advised that the installation/maintenance/modification/repair work of FSI shall be undertaken by a registered Fire Service Installation Contractor (RFSIC). The RFSIC shall after completion of the installation/maintenance/modification/repair work issue to the person on whose instruction the work was undertaken a certificate (FS 251) and forward a copy of the certificate to him;
- (l) to note the comments of the Chief Engineer/Mainland North, Drainage Services Department that the applicant should maintain the drainage facilities as those implemented under previous Application No. A/YL-TYST/443 on site in accordance with the agreed drainage proposal. The applicant is required to rectify the drainage system if they are found to be inadequate or ineffective during operation. The applicant shall also be liable for and shall indemnify claims and demands arising out of damage or nuisance caused by a failure of the drainage system. The development should neither obstruct overland flow nor adversely affect any existing natural streams, village drains, ditches and the adjacent areas. The applicant should consult DLO/YL, LandsD and seek consent from the relevant lot owners for any works to be carried out outside his lot boundary before commencement of the drainage works;
- (m) to note the comments of the Chief Engineer/Construction, Water Supplies Department that for provision of water supply to the development, the applicant may need to extend his/her inside services to the nearest suitable government water mains for connection. The applicant shall resolve any land matter (such as private lots) associated with the provision of water supply and shall be responsible for the construction, operation and maintenance of the inside services within the private lots to his department’s standards;
- (n) to note the comments of the Chief Building Surveyor/New Territories West, Buildings Department (BD) that if the existing structures (not being a New Territories Exempted House) are erected on leased land without the approval of the BD, they are unauthorized building works (UBW) under the Buildings Ordinance (BO) and should not be designated for any proposed use under the application. For UBW erected on leased land, enforcement action may be taken by the BD to effect their removal in accordance with BD’s enforcement policy against UBW as and when necessary. The granting of any planning approval should not be construed as an acceptance of any existing building works or UBW on the Site under the BO. Before any new building works (including containers/open sheds as temporary buildings and land filling) are to be carried out on Site, prior approval and consent of the BD should be obtained, otherwise they are UBW. An Authorized Person should be appointed as the co-ordinator for the proposed building works in accordance with the BO. The Site shall be provided with means of obtaining access thereto from a street and emergency vehicular access in accordance with Regulations 5

and 41D of the Building (Planning) Regulations (B(P)R) respectively. If the Site does not abut on a specified street of not less than 4.5m wide, its permitted development intensity shall be determined under Regulation 19(3) of B(P)R at the building plan submission stage;

- (o) to note that the erection of fence walls and external mesh fences on private land are building works subject to the control under the BO. The applicant should obtain the Building Authority's prior approval of plans and consent for commencement of works or, if such works fall within the scope of the Minor Works Control System, the applicant should ensure compliance with the simplified requirements under the Buildings (Minor Works) Regulation; and
- (p) to note the comments of the Director of Electrical and Mechanical Services that in the interests of public safety and ensuring the continuity of electricity supply, the parties concerned with planning, designing, organizing and supervising any activity near the underground cable or overhead line under the application should approach the electricity supplier (i.e. CLP Power) for the requisition of cable plans (and overhead line alignment drawings, where applicable) to find out whether there is any underground cable and/or overhead line within and/or in the vicinity of the Site. They should also be reminded to observe the Electricity Supply Lines (Protection) Regulation and the "Code of Practice on Working near Electricity Supply Lines" established under the Regulation when carrying out works in the vicinity of the electricity supply lines.
