Approval Condition(s):

- (1) Submission and/or implementation of (accepted) landscape and/or tree preservation proposals.
- (2) Paving and/or fencing of the application site.
- (3) Submission of (revised) drainage proposals and/or provision/implementation of (accepted) drainage facilities/proposal.
- (4) Submission and/or implementation of (accepted) water supplies for firefighting/fire service installations/emergency vehicular access proposal(s)/provision of a 9-litre water type/3kg dry powder fire extinguisher/ fire extinguisher(s) with valid fire certificate (FS 251).
- (5) Revocation of planning approval for non-compliance with conditions by a specified date/at any time during the approval period.
- (6) Reinstatement of the application site upon expiry of planning permission.
- (7) No open storage is allowed on the site.
- (8) No (night-time) operation during specific time limit is allowed on the site.
- (9) Submission and implementation of run-in/out proposal.

Rejection Reason(s):

- (1) No/insufficient information in the submission to demonstrate that the development would not generate adverse environmental impact.
- (2) No/insufficient information in the submission to demonstrate that the development would not generate adverse drainage impact.
- (3) No/insufficient information in the submission to demonstrate that the development would not generate fire safety impact.
- (4) The application involves previously revoked planning permissions due to non-compliance with the approval conditions. Approval of the application with repeated non-compliances would set an undesirable precedent for other similar planning permissions for temporary uses, nullifying statutory planning control.

Advisory clauses

- (a) prior planning permission should have been obtained before commencing the proposed development on-site;
- (b) to resolve any land issues relating to the development with the concerned owner(s) of the application site (the Site);
- (c) to note the comments of the District Lands Officer (DLO)/Yuen Long, Lands Department that the Site comprises Old Schedule Agricultural Lots held under the Block Government Lease which contains the restriction that no structures are allowed to be erected without the prior approval of the Government. The government land (GL) within the Site is covered by Short Term Tenancy (STT) No. 2710, Lot 1265 in D.D.119 is covered by Short Term Waiver (STW) No. 3829, Lots 1270 and 1271 are covered by STW No. 3830, Lot 1266 is covered by STW No. 3831, Lot 1272 is covered by STW No. 3832, Lots 1273, 1275 RP, 1277 S.A and 1277 RP are covered by STW No. 3833, and Lot 1276 is covered by STW No. 4492 to permit structures erected thereon for the purpose of "Warehouse of storage of sanitary ware, metal ware, machinery and spare parts". The Site is accessible from Kung Um Road via GL and private land. Her office provides no maintenance work for GL involved and does not guarantee any right-of-way over the GL to the Site. Should planning approval be given to the subject planning application, the STT/STW holder(s) will need to apply to her office for modification of the STT/STW conditions where appropriate. The owner(s) of the lot without STW will need to apply to her office to permit the structures to be erected or regularize any irregularities on site, if any. Besides, given the proposed use is temporary in nature, only application for regularization or erection of temporary structure(s) will be considered. No construction of New Territories Exempted Building(s) will be considered or allowed. Applications for any of the above will be considered by her department acting in the capacity as landlord or lessor at its sole discretion and there is no guarantee that such application will be approved. If such application(s) is approved, it will be subject to such terms and conditions, including among others the payment of premium or fee, as may be imposed by her department;
- (d) to note the comments of the Commissioner for Transport that the land status of the access road/path/track leading to the Site from Kung Um Road shall be checked with the lands authority. The management and maintenance responsibilities of the access road/path/track shall be clarified with the relevant management and maintenance authorities accordingly. The applicant is reminded that sufficient space within the Site should be provided for manoeuvring of vehicles. In addition, no parking of vehicles on public road are allowed;
- (e) to note the comments of the Chief Highway Engineer/New Territories West, Highways Department that adequate drainage measures should be provided to prevent surface water flowing from the Site to the nearby public roads/drains. His office shall not be responsible for the maintenance of any access connecting the Site and Kung Um Road;
- (f) to note the comments of the Director of Environmental Protection that the applicant should be advised to follow the relevant mitigation measures and requirements in the "Code of Practice on Handling Environmental Aspects of Temporary Uses and Open Storage Sites" to minimise any potential environmental nuisances. The applicant should be reminded of his obligation to comply with all relevant environmental pollution control ordinance and to apply for the licence/ permit for disposal of e-waste as defined under the Waste Disposal Ordinance as necessary;

- (g) to note the comments of the Chief Town Planner/Urban Design and Landscape, Planning Department that the applicant is advised that the approval of the landscape proposal does not imply approval of tree works such as pruning, transplanting and felling under lease. Tree removal applications should be submitted direct to DLO for approval. The applicant is reminded of the importance of undertaking proper tree care for the existing trees. - (h) to note the comments of the Chief Engineer/Construction, Water Supplies Department (WSD) that the applicant would undertake that a waterworks reserve within 1.5m from the centerline of the water main shall be provided to WSD; no structure shall be built or materials stored within the waterworks reserve; free access shall be made available at all time for staff of the Director of Water Supplies and their contractor to carry out construction, inspection, operation, maintenance and repair works; no trees or shrubs with penetrating roots may be planted within the waterworks reserve or in the vicinity of the water main; and government shall not be liable to any damage whatsoever and howsoever caused arising from burst of leakage or the public water mains within and in close vicinity of the Site;
- (i) to note the comments of the Director of Fire Services that in consideration of the design/nature of the proposal, fire service installations (FSIs) are anticipated to be required. The applicant is advised to submit relevant layout plans incorporated with the proposed FSIs to his department for approval. The layout plans should be drawn to scale and depicted with dimensions and nature of occupancy and the location of where the proposed FSIs to be installed should also be clearly marked on the layout plans. The applicant is also reminded that if the proposed structure(s) is required to comply with Buildings Ordinance (BO) (Cap. 123), detailed fire service requirements will be formulated upon receipt of formal submission of general building plans; and
- (j) to note the comments of the Chief Building Surveyor/New Territories West, Buildings Department (BD) that if the existing structures (not being a New Territories Exempted House) are erected on leased land without the approval of BD, they are unauthorised building works (UBW) under the BO and should not be designated for any proposed use under the application. For UBW erected on leased land, enforcement action may be taken by BD to effect their removal in accordance with BD's enforcement policy against UBW as and when necessary. The granting of any planning approval should not be construed as an acceptance of any existing building works or UBW on the Site under BO. Before any new building works (including containers/open sheds as temporary buildings and land filling) are to be carried out on the Site, prior approval and consent of BD should be obtained, otherwise they are UBW. An Authorised Person should be appointed as the co-ordinator for the proposed building works in accordance with BO. The Site shall be provided with means of obtaining access thereto from a street and emergency vehicular access in accordance with

Regulations 5 and 41D of the Building (Planning) Regulations (B(P)R) respectively. If the Site does not abut on a specified street of not less than 4.5m wide, its permitted development intensity shall be determined under Regulation 19(3) of the B(P)R at the building plan submission stage.
