Approval Conditions

- (1) No storage of construction machineries was permitted at the site.
- (2) No (night-time) operation during specific time limit was allowed on the site.
- (3) Submission and/or implementation of the (accepted) landscaping and/or tree preservation proposals.
- (4) Submission and implementation of noise and dust mitigation proposals.
- (5) Submission and/or implementation of drainage proposal/drainage impact assessment/flood mitigation measures proposal and/or provision of drainage facilities.
- (6) Submission and/or implementation of FSIs proposal/provision of a 9-litre water type/(3kg dry powder) fire extinguishers.
- (7) Revocation of planning approval for non-compliance with conditions by a specified date/at any time during the approval period.
- (8) Reinstatement of the application site upon expiry of planning permission.
- (9) No dismantling/repairing/cleansing/recycling/dismantling/assembling or other workshop activities would be allowed.
- (10) No operation was allowed on Sundays and public holidays.
- (11) The landscape planting should be maintained at all times.
- (12) The existing drainage facilities on the site should be maintained.
- (13) No plastic waste/electronic waste/used electrical appliances were allowed to be stored or processed.
- (14) No heavy vehicles (i.e. over 24 tonnes) or container tractors/trailers were allowed for the operation.
- (15) Maintenance/provision of boundary fence on the site.
- (16) No open storage activities would be allowed.
- (17) A set back from the northern boundary of the site was required to ensure the preservation of the *Dimocapus longan*.
- (18) Submission/implementation of run-in/out proposal.
- (19) No storage or handling (including loading and unloading) of used electrical appliances, computer/electronic parts (including cathode-ray tubes) or any other types of electronic waste is allowed on the site.
- (20) No storage and handling (including loading and unloading) of electronic/electrical appliances outside the concrete-paved covered structure are allowed.
- (21) no queuing and reverse movement of vehicle onto public road are allowed.

Rejection Reasons

- (1) Not in line with the planning intention of the “GB” zone.

- (2) Not comply with the Town Planning Board Guideline for Application for Open Storage and Port Back-up Uses in that it is not compatible with the surrounding area which is rural in character and the well-vegetated hill-slopes to the immediate south.
- (3) No/insufficient information in the submission to demonstrate that the development would not cause adverse environmental and/or drainage impact on the surrounding areas.
- (4) Approval of the application would set undesirable precedent for other similar applications within the "GB" zone, which would result in a general degradation of the environment of the area.

- (1) Submission and/or implementation of (accepted) landscape and/or tree preservation proposals.
- (2) Paving and/or fencing of the application site.
- (3) Submission of (revised) drainage proposals and/or provision/implementation of (accepted) drainage facilities/proposal.
- (4) Submission and/or implementation of (accepted) water supplies for firefighting/fire service installations/emergency vehicular access proposal(s)/provision of a 9-litre water type/3kg dry powder fire extinguisher/ fire extinguisher(s) with valid fire certificate (FS 251).
- (5) Revocation of planning approval for non-compliance with conditions by a specified date/at any time during the approval period.

Rejection Reason(s):

- (1) No/insufficient information in the submission to demonstrate that the development would not generate adverse environmental impact.
- (2) No/insufficient information in the submission to demonstrate that the development would not generate adverse drainage impact.
- (3) No/insufficient information in the submission to demonstrate that the development would not generate fire safety impact.

(4) The application involves previously revoked planning permissions due to non-compliance with the approval conditions. Approval of the application with repeated non-compliances would set an undesirable precedent for other similar planning permissions for temporary uses, nullifying statutory planning control.

Advisory clauses

- (a) prior planning permission should have been obtained before commencing the applied use at the application site (the Site);
- (b) to resolve any land issues relating to the development with the concerned owner(s) of the Site;
- (c) should you fail to comply with any of the approval conditions again resulting in the revocation of planning permission, sympathetic consideration may not be given to any further applications;
- (d) to note the comments of the District Lands Officer/Yuen Long, Lands Department (DLO/YL, LandsD) that the Site comprises Old Schedule Agricultural Lots held under the Block Government Lease which contains the restriction that no structures are allowed to be erected without the prior approval of the Government. Within the Site, the Government land (GL) is covered by Short Term Tenancy (STT) Nos. 2817 and 2825 to permit structures erected thereon for the purposes of 'Temporary Warehouse for Storage of Home Appliance and Furniture and Ancillary Site Office' and 'Temporary Open Storage of Construction Machinery and Construction Materials' respectively. Also, Lots 744 S.A, 744 S.B, 752, 755, 756&757, and 750&751 in D.D. 117 are covered by Short Term Waivers (STWs) Nos. 3999, 4000 and 4001 respectively to permit structures erected thereon for the purpose of 'Temporary Warehouse for Storage of Home Appliance and Furniture and Ancillary Site Office'. Meanwhile, Lot 745 in D.D. 117 is covered by STW No. 4033 to permit structures erected thereon for the purpose of 'Temporary Open Storage of Construction Machinery and Construction Materials'. Furthermore, Lots 747, 749&753 and 754 in D.D. 117 are covered by STWs Nos. 4479, 4481 and 4482 respectively to permit structures erected thereon for the purpose of 'Temporary Warehouse for Storage of Clothes and Household Products and Logistics Centre'. The Site is accessible from Kung Um Road via GL. Her office does not provide maintenance work for the GL involved and does not guarantee any right-of-way over the GL to the Site. The STW/STT holder(s) will need to apply to her office for modification of the STW/STT conditions where appropriate and the lot owner(s) of the lot(s) without STW will need to apply to her office to permit the structures to be erected or regularise any irregularities on site, if any. Besides, given the proposed use is temporary in nature, only application for regularisation or erection of temporary structure(s) will be considered. No construction of New Territories Exempted Building(s) will be considered or allowed. Applications for any of the above will be considered by her department acting in the capacity of the landlord or lessor at its sole discretion and there is no guarantee that such application will be approved. If such application is approved, it will be subject to such terms and conditions, including among others the payment of premium or fee, as may be imposed by her department;
- (e) to note the comments of the Commissioner for Transport that sufficient space within the Site should be provided for manoeuvring of vehicles. No parking of vehicles on public road are allowed;
- (f) to note the comments of the Chief Highway Engineer/New Territories West, Highways Department that adequate drainage measures should be provided at the site access to prevent surface water flowing from the Site to nearby public roads/drains. His department shall not be responsible for the maintenance of any access connecting the Site and Kung Um Road;
- (g) to note the comments of the Director of Environmental Protection that relevant mitigation

measures and requirements in the latest “Code of Practice on Handling the Environmental Aspects of Temporary Uses and Open Storage Sites” issued by the Environmental Protection Department should be followed to minimise any potential environmental nuisances;

- (h) to note the comments of the Director of Agriculture, Fisheries and Conservation that good site practices and necessary water pollution control measures should be adopted and implemented in order to avoid affecting the existing watercourse in the vicinity of the Site;
- (i) to note the comments of the Chief Town Planner/Urban Design and Landscape, Planning Department that approval of the application does not imply approval of tree works such as pruning, transplanting and felling under lease. Tree removal applications should be submitted direct to DLO/YL, LandsD for approval;
- (j) to note the comments of the Chief Engineer/Mainland North, Drainage Services Department that all drainage facilities on site should be maintained in good condition. The development should neither obstruct the overland flow nor adversely affect existing natural stream, village drains, ditches and adjacent areas, etc. The drainage system should be rectified at your own expense to the satisfaction of government parties concerned if they are found to be inadequate or ineffective during operation;
- (k) to note the comments of the Director of Fire Services that the installation/maintenance/modification/repair work of fire service installations shall be undertaken by a Registered Fire Service Installation Contractor (RFSIC). The RFSIC shall after completion of the installation/maintenance/modification/repair work issue to the person on whose instruction the work was undertaken a certificate (FS 251) and forward a copy of the certificate to him. The applicant is reminded that if the proposed structure(s) is required to comply with the Buildings Ordinance (BO) (Cap. 123), detailed fire service requirements will be formulated upon receipt of formal submission of general building plans;

For UBW erected on leased land, enforcement action may be taken by BD to effect their removal in accordance with BD’s enforcement policy against UBW as and when necessary. The granting of any planning approval should not be construed as an acceptance of any existing building works or UBW on the Site under the BO. Before any new building works (including containers/open sheds as temporary buildings, demolition and filling of land) are to be carried out on the Site, prior approval and consent of the BA should be obtained, otherwise they are UBW. An Authorised Person should be appointed as the co-ordinator for the proposed building works in accordance with the BO. The Site shall be provided with means of obtaining access thereto from a street and emergency vehicular access in accordance with Regulations 5 and 41D of the Building (Planning) Regulations (B(P)R) respectively. If the Site does not abut on a specified street of not less than 4.5 m wide, its permitted development intensity shall be determined under Regulation 19(3) of B(P)R at the building plan submission stage; and
- (m) to note the comments of the Project Manager (West), Civil Engineering and Development Department that part of the Site falls within the boundary of the proposed Yuen Long South Development - Stage 2 (the project). The land resumption and clearance programme of the project is subject to Executive in Council’s authorisation on land resumption and Finance Committee’s funding approval. Land clearance operation is tentatively targeted to commence in 2024. Extension of the planning permission may not be supported in future.

No substantial works should be carried out in view of the planned project.
