Proposed Flat, Shop and Services, Eating Place and Minor Relaxation of Plot Ratio Restriction in "Residential (Group E)1" Zone, 21 Wang Yip Street West, Yuen Long (Yuen Long Town Lot No. 461)

I refer to my letter to you dated 3.10.2017.
