**1. Background**

- 1.1 On 30.1.2018, the applicant sought planning application for proposed house (NTEH – Small House) at the application site (the Site). The Site falls within an area zoned “AGR” on the approved Kau Lung Hang Outline Zoning Plan (OZP) No. S/NE-KLH/11 (**Plan R-1**). On 16.3.2018, the RNTPC of the Town Planning Board (the Board) rejected the application.
- 1.2 On 26.4.2018, the applicant applied, under section 17(1) of the Town Planning Ordinance, for a review of the RNTPC’s decision to reject the application. The applicant has not submitted any written representation or technical assessment in support of the review. The review application is scheduled for consideration by the Board on 13.7.2018.

## 2. **Request for Deferment**

On 4.7.2018, the applicant's agent wrote to the Secretary of the Board and requested the Board to defer making a decision on the review application for 8 weeks so as to allow time for preparation of further information in support of the review application (**Annex A**).

## 3. **Planning Department's Views**

3.1 The Planning Department has no objection to the request for deferment as the justification for deferment meets the criteria for deferment as set out in the Town Planning Board Guidelines on Deferment of Decision on Representations, Comments, Further Representations and Applications made under the Town Planning Ordinance (TPB PG-No. 33) in that the applicant needs more time to prepare further information in support of the review application, the deferment period is not indefinite and the deferment would not affect the interests of other relevant parties.

3.2 Should the Board agree to defer a decision on the review application, the application will be submitted to the Board for consideration within three months upon receipt of further information from the applicant. If the further information submitted by the applicant is not substantial and can be processed within a shorter time, the application could be submitted to an earlier meeting for the Board's consideration. The applicant should be advised that the Board has allowed two months for preparation of submission of further information, and no further deferment would be granted unless under very special circumstances.

## 4. **Decision Sought**

The Board is invited to consider whether or not to accede to the applicant's request for deferment. If the request is not acceded to, the application will be submitted to the Board for consideration at the next meeting.
