1. This application is a renewal application so that all the development parameters of the current application are the same as the last planning permission No. A/HSK/386.
2. The application site subjects to three previous planning permissions since 2017. The applied use of the current application is the same as the approved use of the previous planning permission since 2017.
3. The proposed development would not jeopardize the planning intention of "V" zones because the proposed development is temporary in nature.
4. All the planning conditions imposed to the last planning permission have been complied with.
5. The operation hours of the proposed development is 24 hours from Mondays to Sundays including public holidays.
6. The proposed development is compatible with the surrounding environment.
7. The application site is intended to cater for the parking need of the nearby villagers so that it should receive sympathetic consideration of the Town Planning Board.
8. Minimal traffic impact.
9. Insignificant environmental and noise impacts because the application site is not close to residential developments.
