The proposed development is a Column 2 use in the "Village Type Development" ("V") zone. The intension of the proposed development is to provide social activities to the local villages in Sik Kong. Hence, it is believed that the most of the visitors will visit the site on foot. The provision of 3 parking space is deemed enough for the visitors.

The proposed development which only occupied a site area of 840 sq m only. A similar application for private club (i.e. A/HSK/495) with larger scale to serve the local villagers in San Wai has been approved by the Town Planning Board in the same "V" zone in 2023. Preferential treatment should be granted to the current application (renewal of 5 years application). In view of the nature / scale, insignificant environmental impacts/ nuisance are anticipated to the surrounding environment.

Compared with the last application (No. A/HSK/409), the applicant confirmed that there will be no change on the proposed use and all the layout remain unchanged. The last application has been approved with conditions by the Board in October 2022. To support the renewal of the application, the applicant here to submit the existing drainage proposal (which has been satisfied by DSD) and the submission of the fire service installation with the latest annual inspection report for your consideration.
