7. Justifications 理由

1. The application site is subject to a five previous planning permissions No. A/YL-HT/953, A/HSK/50, 216, 389 & 439 since 2015 approved for exactly the same use within the same application site. An ancillary staff canteen is proposed for the convenience of site staff.
2. The applicant has complied with all the planning conditions imposed to the last planning permission so that he should be rewarded another three years of operation at the application site.
3. The proposed development conforms to the Town Planning Board Guidelines for Application for Open Storage and Port Back-up Uses (TPB PG-NO. 13G) because it is subject to previous planning permissions.
4. The proposed development is a temporary use for a period of 3 years which would not jeopardize the long term planning intention of the current zoning.
5. The proposed development is not incompatible with the surrounding environment including open storage use and port back-up activities.
6. Open storage & port back-up uses adjoining the application site such as No. A/HSK/501 & 522 were granted with planning permission. Similar preferential treatment should be granted to the current application.
7. Neither recycling, cleaning, repairing, dismantling work nor workshop activity would be allowed on the application site.
8. Shortage of land for port back-up purpose in Ha Tsuen.
9. The planning circumstance pertaining to the application site is similar to the recent approval of adjacent open storage yards and port back-up uses.
10. Minimal traffic impact.
11. Insignificant environmental and noise impacts because the applied uses are housed within an enclosed structure.
12. Insignificant drainage impact because surface U-channel is provided at the application site.
