
1. The application site is subject to five previous planning permissions since 2015. Since 2019, the last three planning permissions were approved for open storage use.
2. The applicant has complied with all the planning conditions imposed to the last planning permission No. A/HSK/430.
3. The proposed development would not jeopardize the planning intention of "R(A)3" zone because the proposed development is temporary in nature.
4. The application site is subject to previous planning permissions so that favourable consideration should be granted according to Town Planning Board Guideline No. 13G.
5. The operation hours of the proposed development is 7:00a.m. to 11:00p.m. from Mondays to Saturdays. No operation will be held on Sundays and public holidays.
6. The proposed development is compatible with the surrounding environment.
7. Construction material and machinery such as electric generators, metal and barricades were stored at the application site. It could support the need of the infra-structural projects in Hong Kong such as northern metropolis.
8. Shortage of land for port back-up purpose in Ha Tsuen.
9. Minimal traffic impact.
10. Insignificant environmental and noise impacts because the no operation will be held during sensitive hours.
11. Insignificant drainage impact because surface U-channel has been provided at the application site.
12. No repairing, cleansing, dismantling and workshop activity would be allowed on the application site.
13. No container trailer/tractor, as defined in the Road Traffic Ordinance, would be allowed to enter/exit or to be parked/stored on the application site.
