This application seeks permission for the temporary use of land to deploy a local High-Frequency Radar (HFR) network. This network is designed to monitor the sea conditions in two key areas of Hong Kong waters: the Central Waters and the exit of the Pearl River Estuary.

The radar network is funded by a grant from the Research Grants Council of Hong Kong. (Proj. No. C5032-22EF).

This application should be considered as a non-standard application for two main reasons: first, the area of land required is minimal and is strictly limited to the footprint necessary for the installation of essential equipment; second, the purpose of the land use is non-profit and serves the public interest by contributing to enhanced coastal resilience and public safety.

The critical importance of this initiative has been recognized and endorsed by the Development Bureau and other relevant Departments (CEDD, HKO, DSD). The present initiative is aligned with the Hong Kong SAR Government's broader strategic policies, particularly the Climate Action Plan 2050.
