Proposed Public Utility Installation (Aboveground Gas Governor Kiosk) In "Road (footpath)" at Shatin Pass Road near Shatin Pass Estate, Tsz Wan Shan Application for Permission under Section 16 of the town planning ordinance (CAP.131) Planning Application No. A/K11/248

Further to our Application for Permission under Section 16 of the town planning ordinance (CAP.131) Planning Application No. A/K11/248, we would like to provide the following to justify our application.

- (a) The proposed kiosk is to reinforce the existing gas supply network and enhance gas supply security to Tsz Wan Shan area. The kiosk would be in form of Stainless Steel of size 2.8m x 2.2m x 1.8m (H) with the floor area of 6.2m². As the location falls within area zone 'Road' on the approved Tsz Wan Shan, Diamond Hill & San Po Kong OZP no. S/K11/31, it requires planning permission from the Town Planning Board (the Board) according to the Notes of the OZP.
- (b) The gas supply of Shatin Pass Estate is currently relied from the kiosk in Tsz Ching Estate and a single 800m Low Pressure (B) gas pipe. In addition, this kiosk is currently supplied gas with over 21,000 customers. By installing a new governor and link up the pipelines, a ring supply can be made.
- (c) The Site is the most suitable location for the proposed kiosk after considered various factors, including the avoidance of obstruction to pedestrian and traffic flow, compatibility with existing structures and other utilities installations, and ease of future operation and maintenance. Moreover, it locates at a sufficient distance away from nearby buildings and structures, proximity is fully considered.
- (d) The proposed kiosk is made of stainless steel with a fire resistance period of two hours and a fire extinguisher will be installed in the kiosk. An automated system will also be installed to switch off the gas governor in case of a gas leak. The existing railing near the Site can protect the proposed kiosk from vehicles damages.
