**Response-to-Comment**

**Proposed Hotel (Student Hostel) in “Other Specified Uses” annotated “Business” (“OU(B)”) Zone  
and Area shown as ‘Road’, LT Tower, 31 Chong Yip Road, Kwun Tong, Kowloon**

**(S.16 Application No. A/K14/839)**

- (i) The applicant provides the following clarifications on the captioned application:
- the management office of the proposed hostel will impose time restrictions on the use of recreation facilities on 13/F so as to alleviate the potential noise impact to the occupants on the same floor, as well as the floor beneath;
  - an additional full-height wall with solid door is proposed on 13/F to separate the recreation facilities with the hostel rooms on the same floor to further minimise the potential noise concern (Plan 4i of **Annex 1**);
  - the applicant would also explore the use of materials such as sound-absorbing paddings/ panels in the indoor ball courts to minimise the potential noise impact; and
  - occupants will also be reminded not to generate excessive noise in the proposed hostel at any time. The management office will make sure that the operation of the proposed hostel will fully comply with the requirements stipulated in the Noise Control Ordinance.
- (ii) The following minor revisions have been made on the floor plans:
- the window width measurements of Room 7 on 2/F-12/F and Room 8 on 2/F-9/F are shown on the respective floor plan of each floor (Plans 4c to 4h of **Annex 1**); and
  - an additional full-height wall with solid door is proposed on 13/F (Plan 4i of **Annex 1**).

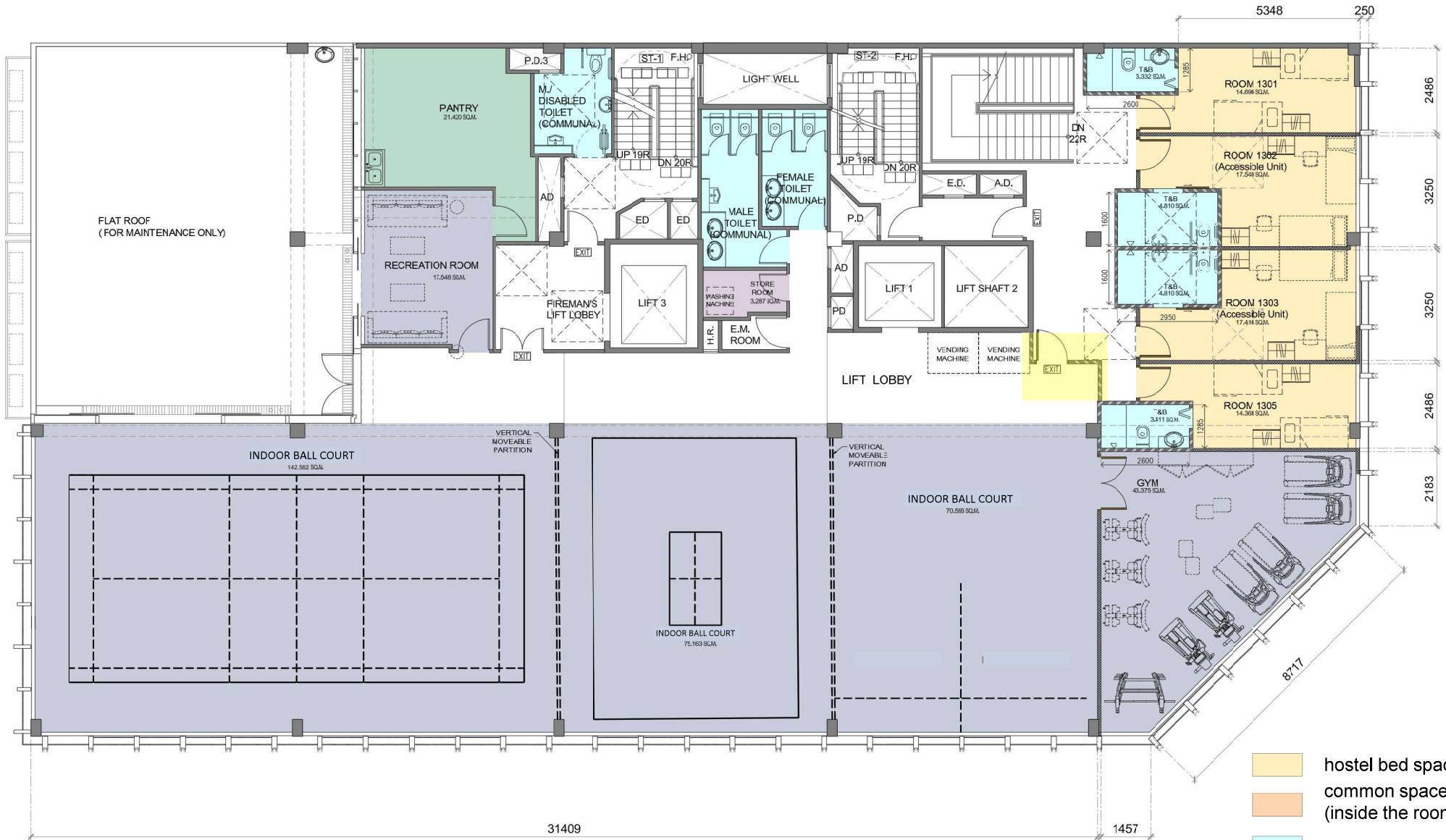
