3.3 To the west of the application site located the Tsuen Wan Chinese Permanent Cemetery, and southwest, the Kwai Chung Crematorium. A cluster of industrial buildings, with building height ranging from 22mPD to 132mPD, is situated east of the application site across Tsuen Wan Road, while the Kwai Chung Sports Ground is further southeast and Kwai Chung Park to the south.

4. Proposed Development

4.1 The application site, with an area of about 964.2m², is proposed to redevelop an existing industrial building into an information technology and telecommunication industries (data centre). The proposed building is about 109.55mPD with 2 basement levels for parking and M&E facilities. In addition, a 3.7m full-height building setback fronting Wing Kin Road, a 2.948m building set back fronting Wing Chong Street from G/F to 1/F and a 6.53m building setback from 6/F and above facing Wing Chong Street are proposed with the provision of planters and vertical greening to enhance visual amenities.

5. Viewing Points

- 5.1 A total of nine VPs are selected for this visual impact assessment. The nine VPs, same as those selected under the previous approved planning application (A/KC/496), are selected from different directions and distances (**Figure 1**). These VPs represent views from key pedestrian nodes, popular areas used by the public for outdoor activities and public open spaces:
 - a. VP1: Wing Kin Road
 - b. VP2: Wing Chong Street
 - c. VP3: Tsuen Wan Chinese Permanent Cemetery
 - d. VP4: Kwai Chung Crematorium
 - e. VP5: Footbridge connecting Kwai Chung Park and Kwai Fuk Road across Tsuen Wan Road
 - f. VP6: Kwai Chung Sports Ground
 - g. VP7: Former Wing Kei Road Trucks Car Park
 - h. VP8: Temporary Cricket Gound in Kwai Chung Park
 - i. VP9: Tsing Yi Waterfront Promenade

6. Visual Assessment

- 6.1 VP1: Wing Kin Road (Figure 2)
- 6.1.1 VP1, located around 20m from the application site, is a short-distance view. VP1 consists of a 2-storey industrial building at the application site, situated between two existing industrial buildings, i.e. Global Trade Centre and Hou Feng Industrial Building. Since VP1 is














