BASIC INFORMATION :

The proposed educational institution is located at Unit 04, 1/F, 83 Tai Lin Pai Road, Kwai Chung, New Territories (hereafter called "Premises". The building in which the Premises is situated is a modernized office building erected in 2019 consisting of a 21-storeys tower sitting on a 2-storeys podium. It is located in the planning zone "Commercial (3)" under Approved Kwai Chung Outline Zoning Plan (No. S/KC/32) in which Educational Institution is "Column-2 Use".

Although there is no educational institution in the building, there are many education centres / tutorial schools at Life@KCC and some few at Kowloon Commerce Centre just opposite to the our building. In addition, many well-established secondary schools are in the surroundings not far away from our building, like Salesians of Don Bosco of Ng Siu Mui Secondary School, Daughters of Mary Help of Christians Siu Ming Catholic Secondary School, Sun Tak Fraternal Association Lee Shau Kee College, etc.

At the south side of the building, a new housing estate of about 600 residential units is under redevelopment by the Housing Authority (formerly Kwai On Factory Estate). To the west of the building across the Kwai Chung Road are some public housing estates and private residential developments, e.g., Kwai Hing Estate, Kwai Fong Estate, Sun Kwai Hing Garden, etc.

The proposed educational institution will offer specially designed courses for students freshly graduated from secondary schools and equip them with strong foundation and know-how knowledge of business field for future studies. Our proposed courses include :

- Accounting
- Economics
- Chinese Business Writing
- Business English
- Finance Mathematics

The contents of these two subjects are specially designed for those students without any basic knowledge and principles in accountancy and economics studies in the secondary schools.

The target students are those who are coming from non-accounting nor non-finance disciplines but wish to acquire foundational knowledge and skills in accounting and economics.

- Chinese Business Writing
- Business English
- Finance Mathematics

The contents of the above three subjects are specially designed for those students already having basic knowledge and principles in accountancy and economics during their studies in the secondary schools. The target students are those who are interested in business field and want to develop their mind for advanced accounting knowledge and practical skills in business communication. Hence, in the three courses above, the students will be taught how to communicate in English, Chinese and even using mathematics in the business communication.

JUSTIFICATIONS:

a) Just near the building are many large residential estates including public and private sectors. There are a lot of households with children and exist a great demands for education. More importantly, there are some secondary school students graduated from schools in the district but they cannot get further studies due to some reasons. Hence there is inadequate supply for this pressing needs for educational institutions in the district.

b) The size of our proposed tutorial school is middle in the district to accommodate such demands for tutorial education. Our size is not big nor small. Hence, it shall not pose any adverse impacts to the current planning intention;

c) Our school teaching aim is to bridge the gap between the secondary education and higher level studies in the district, particularly for those students with interest and ambition in business and accounting field but without chances in further studies in formal school. After completion of our courses, we trust our students will be taught with all round knowledge in business and accounting with practical skills for their benefits in their careers or further studies;

d) Our proposed educational institution in teaching languages, commercial business and accounting is well compatible in the office building. Also in the commercial zoning, our proposed use of Educational Institution relating to commercial and business language education shall be in line with the planning intention of Commercial Use Zoning as stated in the Outline Zoning Plan;

e) Our busy hours of operation do not fall into the traffic peak hours for the public. Also the population generated from our proposed educational institution is very small in the district. Hence our school operation shall not generate any adverse impacts to the current pedestrian system and vehicular transportation;
