1. The applicant, Mr. Lee Joshua, had been given planning permission to build a small house under section 16 of the Town Planning Ordinance on 22 Dec 2017 (Ref. TPB/A/MOS/119) and renewal of the permission on 7 Oct 2021 (Ref. TPB/A/MOS/119-1). As the permission is due to expire on 9 Dec 2025, the Lands Department is still working on the approval of this case, the applicant wishes to apply for planning permission with the same details provided on TPB/A/MOS/119 and TPB/A/MOS/119-1.

2. The original proposed location of the septic tank was near by the retaining wall of house no. 155 and 156, therefore the location had been revised and advised to the Lands Department on 27 Nov 2023 and to the Planning Department on 5 Dec 2023.

3. 100% of the proposed small house site is inside the Green Belt zone and within the Village Environs (VE) Sai O.

4. Seven similar applications (No. A/MOS/52, 73, 90, 91, 105, 112 and 113) for small houses development within "VE" of Sai O were approved by the Board between 2001 and 2016.

5. Applicant wishes sympathetic consideration would be given to this application and permission would be granted.
