申請地點的面積約 2169.59 平方米, 座落虎地坳及沙嶺, 現時為貨櫃貯存及維修用途。申請地段的土地用途主要鄉郊用途, 並混合露天貯物場, 貨倉及空置土地靠近文錦道並使用文錦道入口管制站運輸食品。根據城規會指引編號 13G, 申請地點座落 "第1 類地區 ", 認為適合作露天貯物及港口用途。此外, 城規會過往亦批准多個在該地帶內的同類申請。
