(a)	The applicant shall also advise the management/control measures to be implemented to ensure no queuing of vehicles outside the subject site. In particular the road outside the subject lot is a one-lane two-way carriageway which shall not be blocked;	No gate is proposed at the application site's (the Site) ingress/egress to facilitate smooth entry of vehicle onto the Site. Staff will be deployed by the applicant to direct vehicles entering/exiting the Site. This is to ensure pedestrian safety from passing through the Site entrance.
(b)	The applicant shall advise the provision and management of pedestrian facilities to ensure pedestrian safety; and	
(c)	The concerned access road leading to the subject site from Fan Kam Road is not under TD's purview. The applicant shall obtain consent of the owners/managing departments of the concerned local track for using it as the vehicular access to the subject site.	Noted.
