The development parameters remain unchanged from the previous approval (Application No. A/NE-LCW/8), except the previously proposed dry eco-toilet will no longer be constructed within the campsite. Instead, visitors will use existing village facilities, further reducing the footprint. No additional excavation of land is required.

Align with the planning intention of the zoning

This renewal fully aligns with the planning intention of the "Green Belt" ("GB") zone, which requires small-scale, low-intensity uses compatible with the environment. The proposal includes no permanent structures and preserves the topography of the abandoned farming terraces. It is solely for passive recreational purposes.

Compatible with the surroundings & no adverse impacts

The development remains compatible with the environment by preserving the original farming terraces and adhering to the previously approved drainage and fire service installation proposals. It continues to demonstrate a high degree of technical suitability, ensuring no adverse impacts on the surrounding secondary forest. Furthermore, the established "visit-by-appointment" system and seasonal operation (October to March) effectively regulate use intensity, allowing the environment sufficient time to recover. Our staff will ensure the "Leave No Trace" principles are strictly upheld by a maximum of 40 participants. Regular monitoring will minimize the risk of hill fires and other disturbances to the nearby secondary forest near the camping area.

Long-term beneficial to the public and the remote village communities

The project serves as a key instrument for the long-term sustainability and revitalisation of the remote Mui Tsz Lam village. As a Nature Conservation Management Agreement project funded by the Countryside Conservation Funding Scheme, it facilitates public education and wellness development while engaging local villagers and volunteers in the village revitalisation journey. By preserving the traditional Hakka terrace landscape for public appreciation and education, the proposal provides a unique social benefit that justifies the continued temporary use of the site.

Since the campsite's official opening in 2024, it has successfully hosted over 700 overnight campers, demonstrating a clear and ongoing public need for managed, low-impact experiential learning and wellness spaces in Hong Kong's countryside. This renewal application is fully endorsed and supported by the village representative and landowners, who view the project as an essential catalyst for the village's long-term revitalisation and cultural continuity.
