Comments of the Development Bureau

(1) Please elaborate on the justification on why three relocation sites (i.e. the current application, Nos. A/NE-HLH/77 and A/NE-MKT/42) are needed for the same company.

The original business premises of the applicant consists of different parts which, all such premises located nearby, within the land resumption limit of Fanling North New Development Area (FLN NDA).

Thus, separate applications (No. A/NE-HLH/77 and A/NE-MKT/42) are needed to accommodate business operations of the applicant in a way that, the applicant would continue its business operations as usual with separate relocation sites nearby.

Also, relocated sites are located in the vicinity could support each other during applicant's everyday operation; as well as a synergy effect for applicant's business growth.

Please show the affected area of the business operation (Lots 353 S.A (Part), 353 RP (Part), 352 (Part), 373 (Part), 459 (Part) and 366 RP (Part) in D.D. 52) on an aerial photo to justify that the affected area is about 1,637m².
