- 1. 教育需求**.....
隨著工程行業的發展,對專業技術人才的需求日益增加。該地點的教育機構將提供針對工程車輛操作的專業培訓,滿足市場需求。預計有3種工程車輛課程會舉辦(請詳見附件課程申請文件):.....
•履帶式起重機 [機構: 偉華機械有限公司WAI WAH MECHANICAL LIMITED]
•貨車吊機[機構: 君記工程有限公司KWANKEE (HK) ENGINEERING LIMITED]
•輪胎式液壓伸縮吊臂起重機[機構: 建造機械操作有限公司CONSTRUCTION MACHINERY OPERATING LIMITED]

2. 實務教學
擬設立的課程將涵蓋輪胎式液壓伸縮起重機、履帶式起重機及貨車吊機等操作技術,並依據勞工署的要求進行教學,確保學員獲得必要的技能和知識。提供實習教學,增強學員的實務經驗。

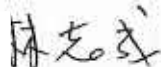
