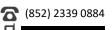

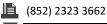

1. Comments of the District Lands Officer/North, Lands Department (DLO/N, LandsD)		
(a)	The application site comprises Old Schedule Agricultural Lots held under the Block Government Lease which contains the restriction that no structures are allowed to be erected without prior approval of the Government. No right of access via Government Land is granted to the application site.	Noted. No structure is proposed for the proposed development at the application site (the Site).
(b)	Lot No. 1644 in D.D. 91 is partly covered by Modification of Tenancy (MOT) No. 32324 for erection of temporary structures for dwelling and kitchen. Lot No. 1511 S.Q in D.D. 91 is covered by Letter of Approval (LoA) No. 6653 for erection of temporary structures for agricultural purpose. This office reserves the rights to take enforcement action for any irregularities and cancel the MOT/LoA as appropriate.	
(c)	It is noted that no structure is proposed in the subject planning application. However, there is a minor portion of structures extended from adjoining Lot No. 1646 in D.D. 91 to Lot No. 1644 in D.D. 91 not covered by the planning application. The lot owners should immediately rectify the lease breaches or advise any toleration was given by competent authority to the structures. This office reserves the rights to take necessary lease enforcement action against the breaches without further notice.	Understanding that the concerned potion of the structure extending from adjoining Lot No. 1646 is falling <u>outside</u> the boundary of the Site, the applicant will remind the lot owner(s) to liaise with respective owner(s) of the adjacent lot over the concerned issue.  The applicant reaffirms that no structure will be erected <u>within</u> the boundary of the Site.
