申請概要及理由

申請人要求批給規劃許可，准許申請地點用作臨時康體文娛場所(休閒農場) (為期 3 年)。場內將設有 1 個總樓面面積不超過 200 平方米及高度不超過 6 米高的構築物用作員工辦公室及顧客休息用途 (見夾附的布局設計圖)，並附設 1 個私人輕型貨車停泊車位。

申請人希望發展一個休閒種植農場，開放給予區內外人士、遊客租用，利用空閒時間到農場參與種植的過程，也能與其他人分享種植的樂趣。申請人計劃把耕地分割為 10 塊，平均約 80 平方米耕地面積，並公開分租給不同居民使用，種植品種不限，包括果樹、蔬菜、鮮花或其他農作物。申請人相信租用者多是以城市家庭租客為主，大多數是在假日及公眾假期前到農場種植及遊玩。即使全數耕地租出，最高峰可容納的人數也不超過 80 人。同時，管理員在開放時段協助管理場地，維持農場秩序及登記租戶進出農場，不接受外來非租戶在繁忙時段進入農場範圍。有關場地也不會提供任何泊車停位，只有一個供上落貨的輕型貨車車位。申請人相信不會造成任何交通問題。根據大綱圖的規定，申請用途於「鄉村式用地」及「綠化地帶」屬第二欄的用途，須向城規會提出申請。而申請的人休閒康樂農場符合“康體文娛場所”地帶的規劃意向，希望城規會能夠批出許可。
