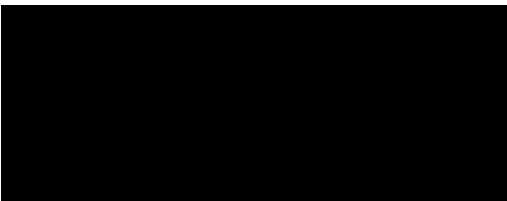

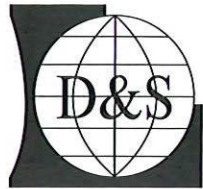

Table 1: Responses to Comments from Government Departments on Planning Application No. A/NE-STK/36 (20.8.2026)

COMMENTS	RESPONSES
1. Transport Department (TD)	
(a) The applicant should demonstrate the adequate width of the local access road leading to the proposed use through private land and unallocated and unleased Government land, including the road width and turning radius. The applicant should also seek comments/approvals from the responsible parties to validate the feasibility for vehicular access at these locations;	(a) The local access road leading to the Application Site is at least 3.5m wide and has passing bays. This is sufficient to accommodate minibus and private car. A swept path analysis for a minibus along the access road is provided in Figure 6 to demonstrate the adequate width of the local access road.
(b) it is noted the shuttle bus service will be provided by the applicant. The applicant should separately submit the application to TD for seeking approval;	(b) Noted. The Applicant will submit the relevant application to the TD for approval of the proposed shuttle bus service upon approval of the planning application.
(c) the applicant should advise the provision of pedestrian facilities to alert pedestrians to the presence of vehicles and ensure pedestrian safety;	(c) Noted. The Applicant will install warning signs and a revolving light at the site entrance to alert pedestrians to the presence of vehicles, thereby ensuring pedestrian safety. There is also a separate access point for pedestrians only.
(d) the applicant should advise the management/control measures to be implemented to ensure no queuing of vehicles outside the application site;	(d) Use of the Application Site will be by prior appointment only, enabling staff to control the number of vehicles arriving. Staff will be stationed on site to manage vehicle entry and exit. In addition, sufficient space has also been reserved at the southern portion of the Application Site for manoeuvring vehicles. These measures will prevent queuing of vehicles outside the Application Site.
(e) the applicant should advise the measures for preventing	(e) Prior appointment is required for all visitor car parking spaces. The

illegal parking of visitors' vehicles outside the application site; and	maximum number of participants for a full-day course will be limited to 22, and visitors will be required to travel to the Application Site by public transport or the shuttle bus service provided by the Applicant. In addition, on-site staff will be deployed to manage vehicle entry and exit. These measures will prevent visitors' from illegally parking their vehicles outside the Application Site.
(f) the proposed vehicular access road between Sha Tau Kok Road - Shek Chung Au and the application site is not managed by TD. The applicant should seek comments from the responsible parties for the proposed vehicular access road.	(f) Noted.
2. Environment Protection Department (EPD)	
(a) the applicant should advise whether sewage will be generated from the proposed use and whether adequate facilities for proper collection, treatment and disposal of the sewage will be provided.	(a) Toilets will be provided in the proposed site office, and a septic tank will be installed to ensure the adequate treatment and disposal of sewage in accordance with the relevant standards.
