1. The proposed development is a public vehicle park for private car. The proposed development will benefit the nearby residents especially for those living at Tsung Yuen Ha and those cross-border travellers.
2. The proposed development is a column 2 use in the 'Recreation' zone.
3. The proposed development would benefit the residents in the vicinity.
4. The proposed development is a temporary use for a period of 3 years which would not jeopardize the long term planning intention of the current zoning.
5. The proposed development is not incompatible with the surrounding environment including vacant land and shop & services.
6. There is an acute demand for parking spaces near Heung Yuen Wai Port.
7. The proposed development is limited in scale and it would not generate undesirable impacts to the surrounding environment.
