1. The proposed development is a public vehicle park for private car. The proposed development will benefit the nearby residents especially for those living at Tsung Yuen Ha and those cross-border travellers.
2. The proposed development is a column 2 use in the 'Village Type Development' zone.
3. The proposed development would benefit the residents in the vicinity and cross-boundary travellers.
4. The proposed development is a temporary use for a period of 3 years which would not jeopardize the long term planning intention of the current zoning.
5. The proposed development is not incompatible with the surrounding environment including public vehicle park and shop & services.
6. There is an acute demand for parking spaces near Heung Yuen Wai Port. The application site is adjacent to the entrance of Heung Yuen Wai Port so that it is an ideal place for meeting the acute parking demand from travellers.
7. The proposed development would be opened for 24 hours to meet the parking demand for cross-border travellers.
8. Minimal traffic impact.
9. No open storage and workshop activities will be carried out at the application site at all times.
10. Insignificant environmental and noise impacts because parking of private car is in inert use.
11. Insignificant drainage impact as proven in the submitted drainage proposal.
12. The application site is subject to a previous planning permission No. A/NE-TKL/N/90 approved for the same as the applied use. The planning permission was revoked due to non-compliance with planning conditions. As such, the applicant submits the access road improvement plan and drainage proposal in support of his application.
