**7. Justifications 理由**

1. The applicant occupied a warehouse for storage of tea leaves at Tong Yan San Tsuen and it has been resumed by Government for Yuen Long South New Development Area. The applicant wishes to relocate his business to the application site.
2. The proposed development is temporary in nature and it would not jeopardize the planning intention of "AGR" zone in the long run.
3. The nature, layout, form and scale of the proposed development is not incompatible with the surrounding environment.
4. Similar precedence were approved in "AGR" zone in North District.
5. Minimal traffic impact as shown in the attached estimated traffic generation.
6. Insignificant environmental impact because no operation will be held between 7:00p.m. to 9:00a.m. The storage of tea leaves will also be housed within an enclosed structures. No workshop activities is proposed.
7. Insignificant drainage impact.
8. The applicant will submit a drainage proposal to support his application.
9. The applicant will follow the relevant mitigation measures and requirements as shown in the revised "Code of Practice on Handling the Environmental Aspects of Temporary Uses and Open Storage Sites".
