Proposed Temporary Warehouse for Storage of Tea Leaves and Associated Filling of Land for a Period of 3 Years at Lot 184 RP (Part) in D.D.79, Ta Kwu Ling, N.T.

DLO/YL informed the applicant to relocate his affected business no later than 29.11.2025 as shown on the attached letter from New Development Area Section of Lands Department. However, the applicant is applying for S.16 planning permission to relocate his affected business to the captioned site so that he cannot discontinue the operation at the affected site at the moment.

We write to confirm that no dangerous goods will be stored at the application site. The proposed land filling is intended for site formation to meet the operation need of the proposed development.

We confirm that the site area should be 555m². As such, para 2.1.7 in the planning statement should be read as follows:


2.1.7 The Site at the application site is deemed suitable for relocation as it's size is most suitable for the relocation of the warehouse for storage of tea leaves at Tong Yan San Tsuen. The site area of the site at the application site (i.e. 555m²) is the most closely to the area of the original site at Tong Yan San Tsuen (i.e. about 770m²).

The applicant confirmed that he will implement relevant mitigation measures listed in the Recommended Pollution Control Clauses for Construction Contracts issued by EPD.

The applicant refers to the similar applications for the relocation of affected business in D.D.90 along Lin Ma Hang Road such as A/NE-MKT/34 & 37 so that he wishes to apply for proposed structures not higher than 8.5m. Also, it is noted that the application site is even smaller than the affected site at Tong Yan San Tsuen so that the applicant proposes to build 8.5m high temporary structures to meet his operation needs.


