The Drainage system and Fire system approved by related department before and remain all unchange. The place can sit around 30 persons.

The subject temporary outdoor seating area forms an integral supporting facility for the existing restaurant operating at G/F, 69B Tai Mei Tuk Village, Tai Po. The restaurant has been operating continuously at this premises and maintains steady local patronage from residents and visitors to Tai Mei Tuk tourist area. Continuation of this temporary outdoor seating arrangement is essential to sustain the restaurants normal business operation.

Tai Mei Tuk is a popular recreational and tourist hotspot in the New Territories. There is consistent public demand for local dining and recreation services. Retention of this temporary outdoor eating place helps meet local visitors' dining needs and supports local village based small scale catering business.

The temporary use is restricted strictly within the approved Government land adjacent to 69B Tai Mei Tuk Village. Throughout the previous approved permission period, the applicant has fully complied with all planning approval conditions, including site boundary control, site tidiness, waste handling, drainage requirements and traffic pedestrian arrangements. No adverse land-use, environmental or safety complaints have been received during the existing approval term.

This remains a temporary proposal only. No permanent structures are introduced on site. All facilities are relocatable and removable. Upon expiry of the renewed permission, all temporary fixtures can be cleared and the government land can be reinstated to its original condition without permanent residual site alteration.
