申請人黎偉康及黎偉揚為親生兄弟，及同為西貢蟻涌村原居民。早於2011年7月5日向西貢地政處呈交興建小型屋宇申請表（黎偉康：西貢地政處檔號=DLO/SK 27/SHL/11，及黎偉揚：西貢地政處檔號=DLO/SK 26/SHL/11），及於2017年10月27日獲城規會批准續期4年興建小型屋宇規劃許可（檔號：A/SK-HC/273）。及後於2021年8月25日再獲城規會發出修訂許可（檔號：A/SK-HC/273-1）。

因地政處處理小型屋宇申請已經需要多於十多年的時間，因此上述所指的規劃許可已超過了發展的期限。而且申請人的擬建屋宇周邊都是小型屋宇，對環境也沒有負面影響，因此懇請城市規劃委員會體諒及恩恤申請人的情況，批准申請。

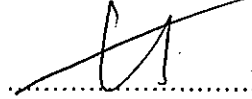
