

Lands Department (Mr. HO Pak-kin, Eric, Tel.: 2451 3249) 2. The following irregularities not covered by the subject planning application have been detected by this office: (i) <u>Unauthorised structures on and extended from the Lot not covered by the planning application</u> There are unauthorized structures on and extended from the Lot. The Lot owner should immediately rectify/regularize the lease breaches, and this office reserves the rights to take necessary lease enforcement action against the breaches without further notice.	<p>Noted. Please note that no structure will be erected within the Subject Site. For parking spaces indication, several number of poles (~2.5m high each) will be used, covered with inflammable nets (black color) as the mark.</p> <p>The concerned structure, which is adjacent to the northeast corner of the Subject Site, is a registered squatter structure. (refer to the figure below [circle in red] and the photo indicates its squatter number) As we are not clear about its current status, we can notify the occupier to apply for Short Term Tenancy (STT) if required.</p>

(ii) <u>Unlawful occupation of Government land not covered by the planning application</u> The Government land adjoining the Site has been fenced off / illegally occupied with unauthorised structures without permission. The Government land being illegally occupied is not included in the application. Please clarify the extent of the Site with the applicant. Any occupation of Government land without Government's prior approval is an offence under Cap. 28. This office reserves the rights to take necessary land control action against the illegal occupation of Government land without further notice.	Noted. The adjoining Government land will be included in the subject planning application for further consideration by the relevant departments, subject to the approval of the Town Planning Board. The applicant understood that the Lands Department does not carry out maintenance works for the Government land covered in this application. However, the applicant is willing to take the responsibility for the maintenance works for the said Government land. Please refer to the revised pages of the application form, Figures 2 & 3, for details.
