這宗規劃申請乃代表申請人向城市規劃委員會(城規會)呈交，擬議在新界藍地青磚圍開設食肆(餐廳戶外坐位區)連附屬儲物室、商店及服務行業(集運自提點)和公眾停車場(為期3年).....

申請地點面積約為650平方米，自2001年用作路邊食肆及餐廳戶外坐位區，擬建發展位於藍地青磚圍村內，擬議發展主要為青磚圍村、屯子圍村及新慶村的居民提供服務，經營期間全部取得食環署牌照，一直經營至今，早前收到規劃署的通知我等在鄉村小型屋宇G/F層開設食肆係不用向城市規劃委員會作出申請許可，但餐廳戶外坐位區在藍地及亦園分區計劃大綱核准圖編號S/TM-LTY/14申請用途於"鄉村式發展"地帶屬第二欄的用途，須向城規會作出申請。

這宗規劃申請理由為：為本地村民及居民提供餐飲服務，多年來一直取得食環署的牌照合法經營，亦並沒有對周邊及鄰近居民產生環境衛生和噪音滋擾，另經村民多次的要求我等增設集運自提站以方便村民網上購買物品，而商店及服務行業亦為"鄉村式發展"地帶屬第二欄的用途，因此我等提出是次申請，申請人希望城市規劃委員會批准3年的臨時許可。

我等食肆合共有10名員工，廚房設置在鄉村屋宇範圍內，而餐廳戶外坐位區共設有10張餐桌，每張餐桌可坐4位客人(請看附圖一)，食肆營業時間為上午7時至下午7時星期日及公眾假期照常營業。

集運自提點共有2名員工，開放時間為早上10時至晚上7時，星期日及公眾假期照常營業。


