致城規會：本人李洛文就申請中的規劃申請編號 A/TM-SKW/135,回應地政總署有關部分位於申請地段 dd375Lots966rp 內的兩個違例構築物的意見，因申請地不包括現時圍街板內存放之貨櫃及雨棚(即佈局設計圖顯示的貨櫃 1，雨棚 1 及雨棚 2)，待城規會完成審批後承諾會盡快搬到申請地段。此外，佈局設計圖已新增一個流動廁所，並會安排持牌承辦商定期處理污水及廢物。

Dear Mr. Lee,

Please find comments from Lands Department on the captioned application for your information.

**Comments from Lands Department (Contact Person: Ringo KWOK; tel: 2451 3310)**

1. The application site (the Site) comprises Old Schedule Agricultural Lot No. 966 RP in D.D. 375 (the Lot) held under the Block Government Lease which contains the restriction that no structures are allowed to be erected without the prior approval of the Government.
2. The Lot is covered by a Short Term Waiver to permit erection of single storey structure with maximum built-over-area not exceeding 14.4m<sup>2</sup> and height not exceeding 2.6m for the purpose of temporary storage (for the use of village office and ancestral hall).
3. His office site inspection conducted in July 2025 revealed that unauthorised structures, including a toilet and a fish tank, were erected within the Lot not covered by the subject planning application. The Lot owner(s) should immediately rectify/regularize the lease breaches and this office reserves the rights to take necessary lease enforcement action against the breaches without further notice.

4. The Lot owner(s)/applicant shall either (i) remove the unauthorised structures not covered by the subject planning application immediately; or (ii) include the unauthorised structures in the subject planning application for the further consideration by the relevant departments and, subject to the approval of the Town Planning Board to the planning application which shall have reflected the rectification or amendment as aforesaid required, apply to his office for modification of STW to permit the structures erected. The application for modification of STW will be considered by the Government in its capacity as a landlord and there is no guarantee that it will be approved. The modification of STW, if approved, will be subject to such terms and conditions including the payment of waiver fee and administrative fee as considered appropriate to be imposed by LandsD. In addition, LandsD reserves the right to take enforcement action against the Lot owners)/applicant for any breach of the lease conditions, including the breach(es) already in existence or to be detected at any point of time in future.

5. The Site is accessible via a local access on Government land leading from So Kwun Wat Tsuen Road. His office does not carry out maintenance works for the said Government land nor guarantee that any right-of-way to the Site will be given. The Applicant shall be responsible for his own access arrangement.

6. his office reserves the right to take lease enforcement actions as considered appropriate against any unauthorised erection/extensions/alterations of the structures erected or to be erected within the Lots or any unauthorised occupation of Government Land at any time irrespective of whether planning permission will be given or not. Enforcement action will be taken should any structure or structures be found erected without prior approval given by his office or be in breach of the approvals given.
