7. Justifications

The Applicant applies for a Temporary Shop and Services with Ancillary Office for a period of 3 years.

Location and Environment

The Application Site is located in the local settlement area known Tai Lam Chung in Tuen Mun. It is accessible via a local roads which connects to Tai Lam Chung Road. The surroundings of the Application Site are mainly abandoned farmlands, village type houses, open-air car park and some open storage area.

Proposed Use, Layout and Operation

The Application Site is 81 sq.m. (about) and currently vacant. The Application Site is unfenced and accessible from all sides in the village. Vehicle access to the Application Site is on its southern side and leads to other parts of the village and Tai Lam Chung Road. The local access tracks in the village have been existed for many years unchanged. There has long been no issues in the use of the local tracks network existed in Tai Lam Chung.

The Applicant is a sole operator with some ad-hoc Small House construction service nearby in Tai Lam Chung. He needs a station for handling paper-works and clerical works in support of this works. He can also station for quick works follow-up matters for the projects nearby. Occasionally, there might be visitor(s) to the ancillary office to discuss construction project related issues. These visitors are all expected to arrive on foot as the projects involved are situated in Tai Lam Chung only.

The Applicant proposes to erect a 2-storey Temporary Structure (TS) as a temporary shop and services with ancillary office for self-use. Both storeys are container converted temporary structure, with one open-air car parking space available next to the TS. It is expected that about very rare vehicle traffic is generated from / to the temporary shop and services with ancillary office. A staircase is provided for access to upper floor from ground floor. The business hours will be 8 a.m. to 7 p.m. every Monday to Saturday (except public holidays).

The Applicant undertakes that the propose private car parking spaces will be used for private cars parking only for the temporary shop and services with ancillary office user only. There will be no other types of vehicles other than private cars to be parked inside the Application Site at the parking spaces. At the same time, there will be no car storage, washing, inspection, maintenance, repairing or washing activities at car parking spaces in the Application Site.

Land Lease Restriction

The Application Site is an agricultural land held under Block Government Lease. The Applicant will apply for Temporary Waiver once the application may be approved to comply with land lease restriction.

No Adverse Impacts

The Applicant will fire services proposal once the application may be approved to address the fire hazard concerns. The temporary shop and services with ancillary office is very small in scale (only similar to 2 open stored containers on ground), there will be no adverse visual and drainage impact. There will be no noise generated from mainly paper-work scenario. The private cars trips expected from the proposed temporary shop and services with ancillary office is minimal compared to the existing private cars access traffic of village residents in Tai Lam Chung.

Similar Planning Approvals

The Application Site is situated in "Village Type Development" zoning. However, the applied use is a temporary use in nature which will not jeopardize the planning intention of the zoning. "Temporary Shop and Services with Ancillary Office" use is considered as tolerable temporary use in the zoning. There are similar recent planning approvals with similar temporary use summarized below for reference:
