8. Justifications 理由

The applicant is invited to provide justifications in support of the application. Use separate sheets if necessary.

1. The applicant is an indigenous villager of Wai Ha of Tai Po Heung and had submitted his Small House application to District Lands Office/Tai Po of Lands Department previously.
2. The application site is part of the subject of previous application (No. A/TP/491) for the development of one Small House, which was approved with conditions on 22.7.2011. Similar planning permission had been granted for Small House development in the vicinity of the Site within the same "Green Belt" zone.
3. According to the Town Planning Board Paper No. 8834 for consideration by Town Planning Board on 27.5.2011, Small House development within "Green Belt" zone for area west of Tung Tsz Road might be permitted in Area A (i.e. the application site) subject to compliance with the "Interim Criteria for Assessment Planning Applications for NTEH/Small House Development in the New Territories."
4. The proposed Small House is compatible with the existing village character. Village houses are located to the immediate north and east of the site. The site had been formed due to the development of the adjacent house in Lot No. 311RP in D.D.14 (see Site Formation Plan and Completion of Site Formation Letter approved by Buildings Department attached). The site is hard paved and easily accessible by a short local track leading to Tung Tsz Road. Thus no extra site formation works and tree telling is required. Grass and shrubs planting is proposed at the edge of the site (see Landscape & Sewage Connection Plan attached).
5. The proposed development would not generate adverse drainage impact. The applicant is willing to reinstate the stormwater drainage system in accordance with the approved Site Formation Plan for the adjacent house in Lot No. 311RP in D.D. 14, to cater the runoff generated.
6. Public sewerage connection is available in Tung Tsz Road, which is in the vicinity of the application site (see Landscape & Sewage Connection Plan attached). Written consent from the adjacent Lot No. 311RP in D.D. 14 had been obtained to permit sewage pipe from the application site to pass through Lot No. 311RP in D.D. 14 (See Consent Letter attached).
7. In view of the above, no topographic constraints, no adverse landscape, visual and environmental impacts will be anticipated. We trust Town Planning Board will give favourable consideration to this planning application.
