CLP received electricity supply application at location near DD 128 in Sha Kong Tsuen.
Based on "Cap. 406 Electricity Ordinance"
Part III
Electricity Supplier's Powers and Obligations
13. Connection and continued supply
(1) Where a fixed electrical installation complies with this Ordinance an electricity supplier shall, within a reasonable time after being requested to do so by the owner of the installation, connect the electricity supply to the installation.
For the new power supply of S/YL-HTF/12 in Sha Kong Tsuen. CLP planned to lay two new 95mm sq. cables for
this project.
The most shortest cable route is to lay cables from existing cable in Highway Polygon to the customer's meter
box. However, the new cable laying work will fall into the CPA zone unavoidably.
New underground cables laid under existing carriageway and vancant, which bring minor impact to existing
landscape of CPA zone. No visual impact would occur after the underground cable laying works.
In conclusion, the above method is the best method with least environmental impact for this application.
