13. Connection and continued supply

(1) Where a fixed electrical installation complies with this Ordinance an electricity supplier shall, within a reasonable time after being requested to do so by the owner of the installation, connect the electricity supply to the installation.

For the New power supply for 1/F No. 31D Sha Kong Tsuen in S/YL-HTF/12, CLP planned to excavate trench to lay two new 95mm sq. cables with size 40m(L) x 0.45m(W) x 1.2m(D) and back fill the trench for the last procedures of this project. No tree will be removed.

The most shortest cable route is to lay cables from existing cable in Highway Polygon to the sustamer's mater.

The most shortest cable route is to lay cables from existing cable in Highway Polygon to the customer's meter box. However, the new cable laying work will fall into the CPA zone unavoidably.

New underground cables laid under existing carriageway and vancant, which bring minor impact to existing landscape of CPA zone. No visual impact would occur after the underground cable laying works.

In conclusion, the above method is the best method with least environmental impact for this application.
