Regarding the captioned application, please be informed that

- 1. All cats will be kept inside an enclosed structure built with soundproofing materials and equipped with mechanical ventilation and air-conditioning system.
- 2. The existing site level of the application site is +16.4 mPD.
- 3. I confirm that there has been no change to the existing structure in terms of major development parameters since the last approved application, except the increase in floor area. The increase of floor area from 55 sq.m to 110 sq.m is to rectify the countable floor area of the erected two-storey structure which was not fully reflected in the previous applications.
- 4. The fire service installations proposal and implemented fire services installations submitted under the current application is the same as the previous approved application (i.e. A/YL-KTN/828) and there has been no change since then.
- 5. For the LandsD's comment, the erected two-storey structure is not located at any part of Lot No. 4 in D.D. 110. If the current application is approved, the applicant would apply to the LandsD for an Short Term Waiver or modify the existing STW conditions if necessary.


