## 有關對古物古蹟辦事處 A/YL-KTN/1162 的查詢

收悉古物古蹟辦事處對 A/YL-KTN/1162 申請的疑問,本人現書面回覆:

填土及平整方面,本申請之填土及平整的範圍請參考 Appendix 4。會進行填土及平整工程的範圍只有本申請地點的西南方(即 Appendix 4 中以斜線表示),其餘申請範圍不會進行任何形式之填土及平整工程,亦不會將整個申請範圍填到相同或相約的水平高度,會保留現有的水平高度,不會改變現有的地型。

填土及平整物料方面,申請地點現時已使用混凝土填高及平整約 0.3 米,整個以混凝土平整的範圍只有約 370.9 平方米。而連接申請範圍之間的行 人路會以草皮及碎石連住各個範圍。除了約 370.9 平方米會以混凝土平整,其 他地方不會進行填土及平整工程。本人會在申請結束後根據規劃署及地政總署 的要求將鋪地的物料打碎並運走,回復適宜農業的用途,不會為該地造成長遠 影響。


構築物方面,申請地點內的構築物只會使用改裝貨櫃興建,而所以構築物會全部放在以混凝土平整的範圍內,現時現場的建築物是臨時構築物及方便移動,並放在已平整的地面,因此無需進行興建「地腳」等挖掘工程,不會影響地下結構。

挖掘方面,化糞池、滲水系統會沿用舊有系統,無需進行挖掘工程,化 糞池位置請參考 Appendix 2。而申請地點會進行小量挖掘工程,以便興建渠 道,跟據現時的渠道計畫書,會在申請範圍內的西面興建一條約 22 米長,約 225 毫米深及闊的渠道來收集表面流水,其他位置已有溪流及渠道引水,將水 收集並已連接下游渠道 (請參考 Appendix 9-01)。相信不會影響附近及下游的 生態,附近的污染達至零污染,亦能保護地下具考古研究價值的範圍,希望 貴處諒解。

希望此附加文件能釋除 貴處的隱憂,並支持本申請。
