

(a) Photos 3, 15 and 16: Wire mesh was found in existing catchpit that water flow might be obstructed.	The wire mesh is removed. Please refer to the updated photographic record showing the existing drainage facilities on the application site (Annex I).
(b) Photo 16: Condition of existing 225 mm (W) surface channel at the downstream of the catchpit (with sand trap) CP2 could not be seen in the submitted photo. Our previous comment dated 1.12.2025 remains valid.	Existing 225mm (W) surface channel at the downstream of the catchpit CP2 has been shown.




