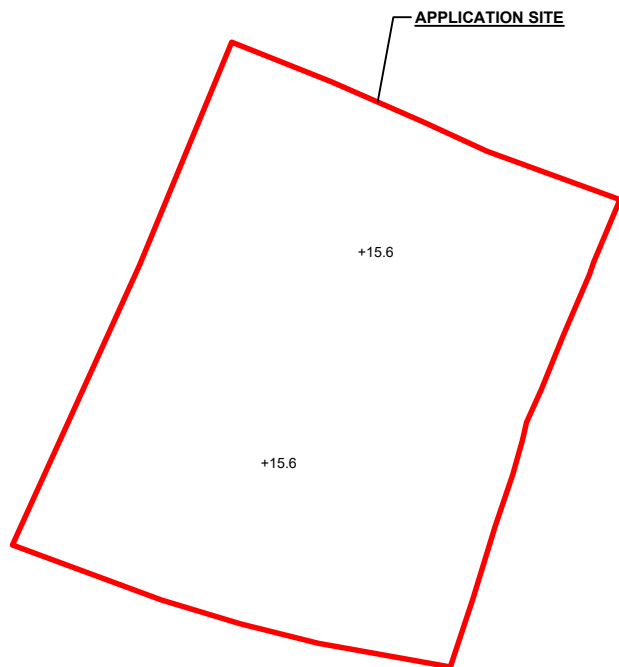

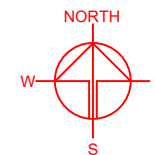

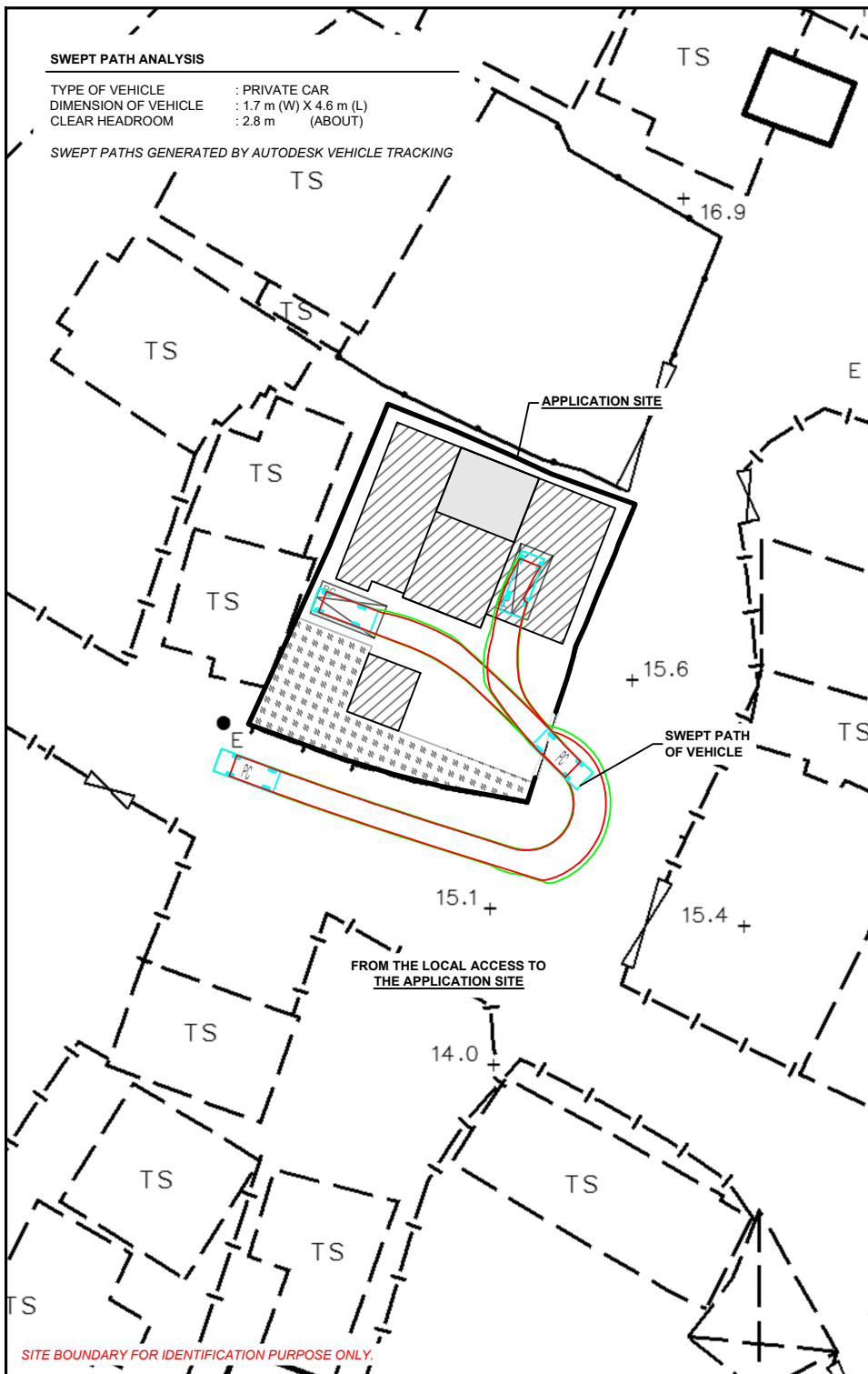

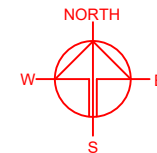
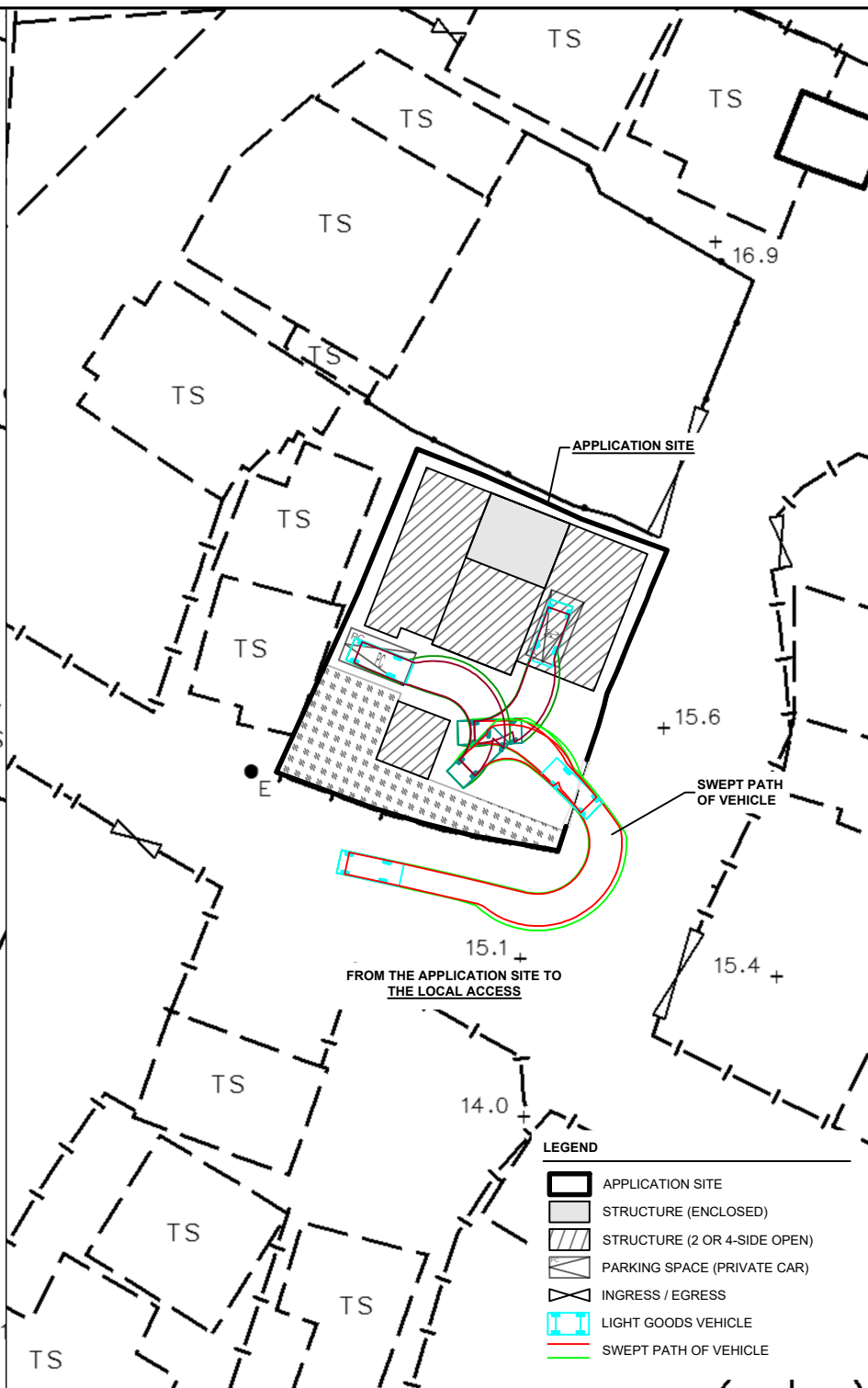
SWEPT PATH ANALYSIS
