(Application No. A/YL-KTN/1266)

- (i) This application is the subject of a previous application (No. A/YL-KTN/1031). During the previous application period, the application site (the Site) was hard-paved for the erection of structures, provision of parking and loading/unloading (L/UL) spaces and circulation spaces, which is considered necessary for the applicant’s operational need. Thus, all trees within the Site have already been felled.
- (ii) To compensate for the tree loss, the applicant proposed to plant 12 new trees with continuous soil trench along the west and northwest periphery boundary of the Site under the current application period (**Appendix III**). The trees can act as a landscape buffer to minimise adverse visual impact to the surrounding areas. In addition, all these new trees within the Site will be maintained by the applicant during the planning approval period. Revised land filling plan and landscape proposal are also enclosed for Government department’s consideration (**Appendices II and III**). For information, the submitted landscape proposal (**Appendix III**) has took forward of the approved landscape proposal of the previous application No. A/YL-KTN/1031; and

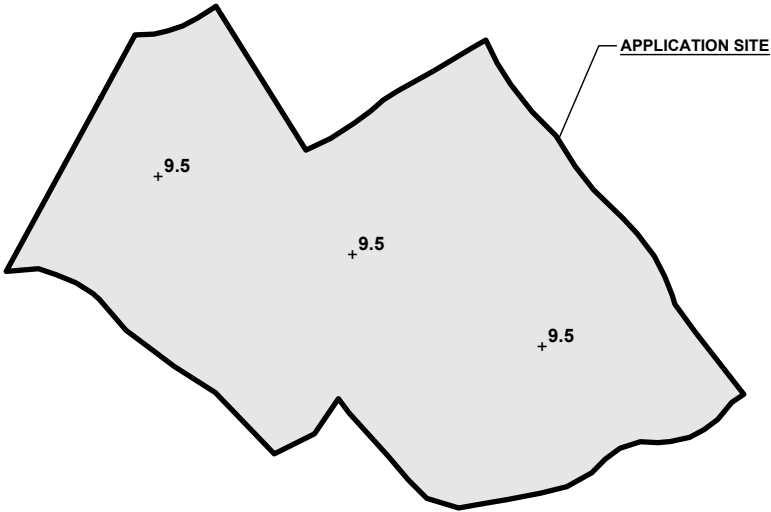

The applicant will apply for modification of Short Term Waiver (STW), as well as to liaise with relevant land owners for a STW application to rectify the applied use on the application site (the Site) after planning permission has been granted from the Board. No structure is proposed for domestic use.

	owner(s) should immediately rectify/apply for regularization on the lease breaches as demanded by LandsD. If the planning application is approved, the STW holder(s) will need to apply to this office for modification of the STW conditions where appropriate, and the lot owner(s) without STW shall apply to this office for a STW to permit the structure(s) erected within the said private lots. The application for STW will be considered by the Government in its capacity as a landlord and there is no guarantee that it will be approved. The STW, if approved, will be on whole lot basis and subject to such terms and conditions including the payment of waiver fee, rent and administrative fee as considered appropriate by LandsD. Besides, given the proposed use is temporary in nature, only erection of temporary structure(s) will be considered.

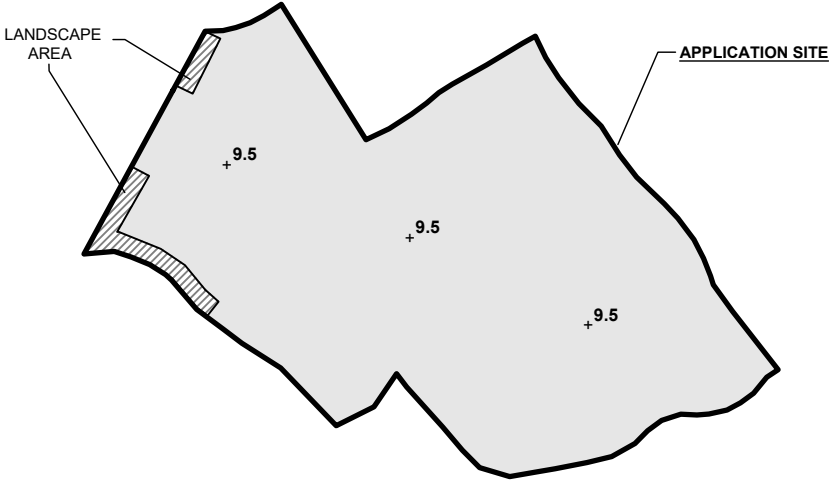
