1. 申請地點是用作暫存政府及私人的綠化招標工程的樹苗,包括細葉榕、鴨腳木和栽種泥盆,申請地點亦會設置植苗(附圖 - 富貴竹),以簡易支架上舖設黑色遮光網構建臨時富貴竹分株種植棚,因應竹怕光和喜歡濕潤的特性,以遮光網遮擋陽光照射,另外有些高大的槙物會暫時依住圍牆邊露天存放,其餘的露天位置用於車輛的迴轉空間。
2. 應對各式綠化招標內包括植物灌溉、修剪、施肥、滅蟲、清潔及修剪樹木等有需要使用的園藝器械及動力裝置,需要以一個20呎長的貨櫃存放,亦需予工人休息用途及個人儲物櫃之用,不會作為居住用途。
