香港政府已明確計劃在2035年或以前停止新登記的燃油私家車，可以預見香港各種類型的車型都將會逐步從燃油車渡到電動車。對於商用車來說，特別是電動的士，由於其運營方式，無法接受慢充甚至中充。慢充或者中充都將佔用大量的充電時間，從而影響的士司機的盈利。高速充電站能够在半小時內甚至十幾分鐘將電動車充滿，而香港現階段很少高速充電站。隨著電動車逐步開始進入香港，充電難和充電時間長的困難已經阻礙了電動車大規模進入香港。為此，我們計劃投資建設高速充電站，以解決電動車充電難的問題。
