1. The proposed development is in line with the planning intention of the 'Village Type Development' ("V") zone which is primarily for the convenience of the villagers and meeting their catering demand.
2. The proposed development is the only eating place at Ha Mei San Tsuen so that outside seating accommodation is necessary to meet the acute catering demand of Ha Mei San Tsuen.
3. The eating place at the G/F of the NTEH is the as-of-right use within 'V' zone whereas the proposed outside seating accommodation is a Column 2 use which requires planning permission from the Town Planning Board.
4. The proposed outside seating accommodation will accommodate not more than 42 persons at the same time.
5. The applicant has complied with all the planning conditions imposed to the last planning permission No. A/YL-PS/678 so that another three years of planning permission should be awarded to the applicant.
6. The proposed development is compatible with the surrounding environment.
7. The application site is subject to a previous planning permission approved for the current use.
8. Minimal traffic impact and the application site is served by an adjoining public vehicle park (TPB Ref. A/YL-PS/740).
9. Insignificant noise and environmental impacts because the operation hours is from 8:00a.m. to 5:00p.m. daily.
10. The applicant has provided surface U-channel at the application site.
11. The proposed development would cater for the catering demand of the villagers of Ha Mei San Tsuen.
12. The applicant will comply with the apporval conditions to be imposed by the Town Planning Board.
