7. Justifications 理由

The applicant is invited to provide justifications in support of the application. Use separate sheets if necessary.

1. All development parameters of the current application are the same as the previous planning permission No. A/YL-PS/714. The applicant has obtained the WWO46 Part 5 for the implementation of FSI proposal now so that a fresh application is submitted for the consideration of the Town Planning Board.
2. The application site subjects to four previous planning permissions since 2015. The applied use of the current application (i.e. shop & services) is the same as the approved use of the previous planning permission since 2021.
3. 2 shops are proposed at the application site. The construction materials being sold (wholesale and retail) at the application site mainly including pipes and tools. Another shop will be specialized in selling private cars.
4. The proposed development is a temporary use for a period of 3 years which would not jeopardize the long term planning intention of the current zoning.
5. The proposed development is not incompatible with the surrounding environment including similar retail and wholesale uses and residential developments.
6. Retail and wholesale uses adjoining the application site were granted with planning permission such as A/YL-PS/737 & 761. Similar preferential treatment should be granted to the current application.
7. All the planning conditions imposed to the last planning permission No. A/YL-PS/714 have been duly complied with except the implementation of FSI proposal because the WWO46 Part V is not on the hand of deceased FSI contractor.
8. The planning circumstance pertaining to the application site is similar to the recent approval of adjacent uses.
9. Minimal traffic impact.
10. Insignificant environmental and noise impacts because the applied use is housed within an enclosed structure and no operation will be held during sensitive hours.
11. Insignificant drainage impact because surface U-channel has been provided at the application site.
12. Loading/unloading bay is proposed for the proposed development. Only light goods vehicle not exceeding 5.5 tonnes will be allowed to enter/park at the application site for the convenience of staff and clients. There is also a public vehicle park outside the application site so that clients could park their car at the public vehicle park before they get into the shop.
13. The application site is not owned by Government so that the acquisition of land for "G/IC" use takes time. As such, the temporary conversion of the application site for another use would be a prudent use of scarce land resource.
14. Wholesale trade is a Column 1 use in the "G/IC" zone which is always permitted. The retail shop for selling construction material is a Column 2 use which requires the permission of the Town Planning Board.
